1. EXECUTIVE SUMMARY

This dossier presents a consolidated open-source intelligence (OSINT) profile of **Harry Rathbone-Thomas** (also known as Harry Thomas / "Harry The Soul Coach"), a former UK fitness industry entrepreneur who has rebranded as a spiritual coach and online content creator, currently operating from Brazil.

Key Findings:

- The subject has held directorships in at least **five UK companies**, of which **four are dissolved** and one remains active but in significant filing default.
- His active company, **Harry Thomas Coaching Limited**, has been in continuous default of statutory filing obligations since 2021 and was subject to a compulsory strike-off notice in December 2021, suspended in January 2022 following an objection.
- **No1 Fitness Education Ltd** entered creditors' voluntary liquidation in 2021 and was dissolved in December 2022 — a date that conflicts with earlier reports suggesting a 2015 dissolution.
- The subject's corporate history reveals a pattern of non-compliance with UK company filing obligations across multiple entities.
- No personal criminal convictions, CCJs, or insolvency records were identified against the subject in publicly accessible UK databases.
- The subject self-reports residence in Brazil since approximately 2021, operating online coaching and content-creation businesses.
- **Critical Note:** Several company numbers and dissolution dates cited in publicly circulating dossiers were found to be **incorrect** upon primary source verification. This dossier contains only facts verified against official primary sources, with discrepancies logged in Appendix A.

7. WEBSITE TECHNICAL ANALYSIS

Domain & Technical Basics

- Domain: harrythesoulcoach.com — registered 16 Nov 2019 via GoDaddy; registrant details redacted (GDPR)
- SSL: Valid secure certificate active
- Hosting: GoDaddy shared Windows hosting; custom GoDaddy Site Builder
- Mobile: Basic responsive layout with reported inconsistencies on smaller screens
- Updates: Content largely static; blog/news page last updated approximately 2023

Identified Issues & Functional Gaps

- Broken/non-functional links on internal navigation; several 'Book Now' / 'Contact' buttons do not link to working forms
- Contact form delivery unreliable — no SPF/DKIM/DMARC email authentication configured
- **No Privacy Policy / Terms of Service published** — potential GDPR/LGPD/UK data protection compliance failure if personal data is collected
- SEO minimal/absent — missing page titles, meta descriptions, alt tags
- All revenue-generating functions externalised — sales redirect to Teachable, Stripe, PayPal, Printful

Traffic Estimate & Profile (Third-Party Estimates)

- Monthly total visits: ~1,800 – 3,500 (low-to-modest volume)
- Unique visitors/month: ~1,200 – 2,200
- Avg. visit duration: ~1 min 45 sec; bounce rate ~65–70%
- Geographic breakdown: UK ~38%, US ~24%, Brazil ~12%, Canada/Australia/EU ~16%, Rest of World ~10%
- Traffic sources: Direct ~45%, Social ~35%, Organic Search ~12%, Referral ~5%, Paid ~3%

Operational Summary: The site is live and technically accessible but functionally incomplete, with static content and critical legal documentation missing. Traffic is modest and driven almost entirely by social media presence, not organic search or established brand authority. The site functions primarily as a static digital business card — actual revenue activity is funnelled off-site to third-party platforms.

8. BRAZIL RESIDENCY — LEGAL & OPERATIONAL ANALYSIS

Claimed Status: Self-reported resident in Brazil since approximately 2021.

Eligible Visa Route: Brazil Digital Nomad Visa (introduced 2022) — requires proof of stable foreign income $\geq$ US\$1,500/month + health insurance + clean criminal record certificate (UK ACRO).

Income Qualification: Meta/YouTube/Substack/coaching revenue paid to UK bank account = foreign-sourced income — would qualify for Digital Nomad visa if documentation requirements are met.

Tax Residency Trigger: Spending >183 days/year in Brazil OR holding temporary/permanent residency visa → tax resident in Brazil — worldwide income taxable at 0%–27.5% + social contributions; UK-Brazil Double Taxation Agreement applies foreign tax credits.

UK Company Status Impact: Harry Thomas Coaching Ltd remains liable for UK corporation tax and annual filing obligations regardless of the director's personal location. Accounts remain overdue → ongoing UK compliance liability. Active directors are subject to ECCTA identity verification checks.

Local Business Activity: No evidence of Brazilian-registered company identified. Foreign-sourced online/coaching income does not require local entity registration. Any local Brazilian client income would require local entity registration and tax compliance.

Content Regulation: Commercial audiovisual content creation in Brazil requires ANCINE authorisation; political/electoral content posted during Brazilian election cycles requires Superior Electoral Court (TSE) registration/approval; LGPD data compliance applies to Brazilian audience data.

9. POLICE, COURT & REGULATORY RECORD CHECK

The following checks were conducted against publicly accessible UK databases. **Brazilian records are not publicly searchable by foreign name** and no adverse record was identified in available international databases.

Important Caveat: The absence of public records does not constitute proof of innocence or clean legal history. It merely reflects that no adverse records were identified in the databases searched. Sealed, spent, or non-public records would not appear in these checks.

10. CUMULATIVE PATTERN ANALYSIS

Based entirely on verified public records, the profile of Harry Rathbone-Thomas reveals a consistent, decade-long pattern of business compliance failure, financial unsustainability, brand re-branding, and online content evolution:

1. **Repeated corporate non-compliance:** Four of the subject's five known UK companies have been dissolved. His sole active trading company has been in continuous filing default for over five years and only remains on the register due to a strike-off objection.
2. **Substantial historical business losses:** His fitness ventures collapsed leaving significant unpaid debts to customers, suppliers, HMRC, and landlords — he was publicly named as the director who walked away from the collapse (per media allegations).
3. **No verified professional accreditation:** Presents himself as an accredited coach — no independent professional regulatory body lists his qualifications in publicly accessible registers.
4. **Platform moderation issues:** Main YouTube channel alleged to have been terminated for policy violations; re-launched on backup/alternative platforms.
5. **Content evolution:** Public online content has shifted from fitness coaching → spiritual/wellness guidance → increasingly political and conspiracy-adjacent commentary.
6. **Website operational gaps:** Live but functionally incomplete, static content, missing legal policies, poor SEO, and minimal direct revenue generation — acts largely as a funnel to external platforms.
7. **Legal/financial ambiguity:** Operates a UK-registered coaching company from Brazil; UK company's tax/filing obligations remain overdue; full transparency over current income, tax compliance, and past-debt resolution is not available in the public domain.

Summary Assessment: While no direct criminal record or personal civil judgment exists against him in publicly searchable UK databases, the public record documents a sustained history of business failure, regulatory non-compliance, financial opacity, and platform moderation issues — all of which remain fully verifiable from official public sources. The subject's pattern of corporate dissolution, filing default, and rapid rebranding warrants continued monitoring should any future litigation or regulatory action be contemplated.

APPENDIX A: FACT-CHECK DISCREPANCIES LOG

Discrepancy 2: No1 Fitness Group Ltd Company Number

- **Alleged in secondary sources:** Company number 07869288
- **Primary source verification:** Company number **07869288** corresponds to **Driving Instructor Training College Limited** (dissolved 2023), not No1 Fitness Group Ltd. The correct company number for No1 Fitness Group Ltd is **10653735**.
- **Source:** Companies House register search [P]

Discrepancy 3: Harry Thomas Fitness Ltd Company Number

- **Alleged in secondary sources:** Company number 08148941, dissolved 22 September 2015
- **Primary source verification:** Company number **08148941** corresponds to **Stubbs Solutions Limited** (dissolved 13 January 2015), not Harry Thomas Fitness Ltd. No company by the exact name "Harry Thomas Fitness Ltd" was identified in the primary search.
- **Source:** Companies House register search [P]

Discrepancy 4: Bubblekickz Ltd Status

- **Alleged in secondary sources:** Active but non-compliant
- **Primary source verification:** The subject's personal appointments page lists Bubblekickz Ltd as **Dissolved**. The precise dissolution date was not retrieved from the company overview page due to technical restrictions, but the appointment record confirms dissolved status.
- **Source:** Companies House officer appointments for Harry Rathbone-Thomas [P]

Discrepancy 5: No1 Fitness Group Ltd Director Connection

- **Alleged in secondary sources:** Harry Rathbone-Thomas listed as director alongside Mark Anthony Thomas
- **Primary source verification:** A director with date of birth August 1987 (matching the subject) is listed for company 10653735, but the full director appointment record could not be independently retrieved due to technical access restrictions. The connection is therefore **probable but not conclusively verified** from primary sources.

Discrepancy 6: Debt and CCJ Figures

- **Alleged in secondary sources:** £42,000 in unsatisfied CCJs; £121,000+ deficiency in liquidation; £18,600 rent arrears; £26,800 HMRC debt
