SUTR's stated goals include:

- Opposing far-right parties such as Reform UK and figures like Tommy Robinson.
- Campaigning against the Illegal Migration Act and deportation policies.
- Organising counter-demonstrations at events perceived as racist or xenophobic.
- Promoting educational trips (e.g. Holocaust memorial visits) and anti-racist training for union members.
