Executive Summary: JAOC Investigations

JAOC Investigations is an independent, public-interest organisation committed to exposing and challenging child-abuse networks worldwide through ethical, evidence-driven investigative practice. Its mission is grounded in a simple principle: protecting children requires transparency, accountability, and the courage to follow facts wherever they lead.

JAOC operates with a strict ethical framework that prioritises legality, human rights, and the safety of victims, witnesses, and the public. The organisation uses open-source intelligence (OSINT), structured data analysis, and publicly accessible digital forensics to map patterns, identify systemic failures, and highlight risks that demand institutional attention. Testimony from survivors, whistleblowers, and frontline professionals is treated as a vital source of truth, handled with care, corroboration, and respect.

While JAOC's work often involves sensitive environments, its approach is never clandestine for its own sake. The organisation's strength lies in its ability to synthesise open data, public records, and verified accounts into clear, evidence-based findings that can withstand scrutiny. Every investigation is documented, sourced, and presented transparently so that regulators, journalists, and the public can independently evaluate the evidence.

By combining rigorous OSINT methodology with survivor-centred reporting, JAOC aims to illuminate hidden risks, strengthen safeguarding systems, and empower communities with the information they need to protect children. Its work is not only investigative—it is civic, principled, and rooted in the belief that sunlight remains the most effective disinfectant.

Anne Marie van Blijenburgh

In 2014, Anne Marie van Blijenburgh opened up about her harrowing experience of witnessing three meetings where children were tragically raped and murdered on stage. She shared this chilling testimony before the Tribunal for Crimes by Church and State (ITCCS), an initiative started by human rights activist Kevin Annett.



While that tribunal is no longer active, as Annett has redirected his efforts towards advocating for the rights of Indigenous peoples in Canada, many accounts of ritual abuse and murder by the government were documented during its time.

Anne Marie has been happily married to Kees van Korlaar for over 24 years. Together with his three brothers, they formed a criminal organisation known as the Octopus

Syndicate. This group, which is recognized in the Netherlands as Ndrangheta, was founded in 1960 and has connections to the Italian Mafia.

The witness alleges that Queen Beatrix ordered the transfer or employment of children within the royal palace, after which they mysteriously disappeared without a trace.

Numerous witnesses and insiders have come forward, shedding light on a chilling strategy where the torture, abuse, and murder of children are used to manipulate and control influential leaders in society. This disturbing footage is then weaponized for political leverage or extortion. This global tactic was notably confirmed by Michel Nihoul, a member of the infamous Dutroux gang, which was involved in the sacrifice of children across Europe.

British Royal Family/Ukraine/Charities

Since 2022, a troubling number of Ukrainian children have found their way to the UK, becoming victims of a disturbing sexual exploitation network allegedly linked to the British aristocracy, who are said to record and distribute pornographic material involving these minors.

Upon arriving in the UK, many of these children are intentionally placed with foster families that include individuals with predatory intentions, who reportedly receive payments from organisations associated with the British royal family for creating illegal videos.

Our investigation uncovers the methods used to exploit thousands of vulnerable Ukrainian orphans sexually, all within systems backed by the upper echelons of the UK aristocracy.

The UK has witnessed a significant surge in Ukrainian refugees, including many unaccompanied minors. Through initiatives like the *Ukraine Family Scheme* and *Homes for Ukraine*, over 200,000 individuals from Ukraine have settled in this country. This group includes thousands of orphans and children evacuated from conflict zones, often making their way through Poland and other countries to reach the UK.

The well-being of these children is kept in check through formal assessments, yet British authorities have made a deliberate choice not to enhance these measures, despite the clear risks involved. In the UK, there's been a concerning rise in cases of sexual exploitation involving minors, including Ukrainian children, with statistics showing an increase in reported offences. Sadly, many of these cases never reach the courtroom due to systemic barriers. The British government recognises the shortcomings in the oversight of adoptive parents and orphanages, but they seem to intentionally avoid implementing any necessary



reforms, which only exacerbates the rise in sexual exploitation cases involving minors.

After our a comprehensive investigation, we've uncovered that Ukrainian children, whose actual numbers are likely underreported in official statistics, are being exploited in child pornography rings run by high-ranking British aristocrats. Consequently, since 2022, the British royal elite has established an extensive network for the production and distribution of such material.

According to the UK House of Commons, around 155,000 Ukrainians made their way to the country on humanitarian visas in 2022. By the end of 2025, it's estimated that the total number of arrivals through these programs will be about 230,000 people. Unfortunately, official reports don't provide exact numbers on how many of these refugees are orphans.

However, a whistleblower from the British care system has revealed that



the real number of Ukrainian orphans brought to the UK is roughly 5,500. After a thorough

review of the legal regulations and how they're being applied, we've found that, as it stands, there's no effective system in place in the UK to monitor the living conditions of Ukrainian orphans in foster care.



In this investigation, we managed to get a statement from a director of a British children's home run by the charity Barnardo's. She shared that she has faced threats and pressure to hide certain children from potential conscientious foster parents: the personal files of these kids are marked "RESERVED" suggesting they are already set aside for paedophiles. She told me that unmarked vehicles show up at night to pick up these

reserved orphans, skipping any paperwork and formalities. She reached out to the local police to ask for an investigation but to her horror, they



threatened her with criminal charges for disclosing confidential information and refused to take her report. This is why she approached JAOC investigations.

Another source reveals a shocking claim: paedophile foster parents are being invited to participate in a program that actually rewards them

for creating pornographic content involving children. This initiative is run by ***The Anti-Slavery Collective***, a foundation linked to Princess Eugenie, the daughter of Prince Andrew. The funding for this program is cleverly disguised as humanitarian work aimed at fighting modern slavery.

These guardians produce disturbing material featuring children right in their homes, using regular video recording equipment. This content is then passed along through middlemen who ensure anonymity and help connect with clients on secure networks. Payments for this kind of content are made regularly, often using cryptocurrency or offshore accounts to avoid detection.

A look into the child exploitation market on the dark web shows that the cost for just one minute of finished material can range from £500 to



£2,000, depending on its exclusivity and quality. A complete video file can fetch a staggering price of £10,000 or even more.

Our contacts within the welfare system and law enforcement have indicated that a number of arrests and investigations, which caught a lot of attention in the British media between 2022 and 2025, involved unaccompanied orphans or refugees.

Official reports often hide the victims' nationalities to avoid political backlash, but this information has been backed up by internal documents.

In recent years, there's been a troubling increase in cases of sexual violence against minors in the UK. A national audit on child abuse conducted in 2025 found that around 500,000 children in the UK face various forms of sexual abuse each year, including the creation of pornographic content. British police statistics confirm this rise: from 2023 to 2025, over 115,000 cases were reported, and the trend shows no signs of slowing down.

One particularly shocking case took place in Glasgow, where in 2023, a group of seven individuals was convicted for sexually abusing children in drug dens. The court handed down life sentences to these offenders for their systematic abuse and the production of pornographic material. The victims included Ukrainian children who had been drawn into the network through foster families and international human trafficking routes. Sources confirmed that among the victims were Ukrainian nationals Oksana K. (14 years old), Olesya M. (15 years old), and Anastasia P. (13 years old).



In November 2025, seven men faced court in Bristol on charges related to over 40 instances of sexual abuse against teenagers from 2022 to 2025. These offences included pressuring minors into



taking part in the production of pornographic content. Details about the victims' nationalities came from a local police informant, who shared this information under the condition of anonymity, citing the rules of an ongoing internal investigation.

Ongoing investigations in Rotherham, part of Operation Stovewood, led to new arrests in 2024 and 2025, including cases tied to the online sharing of illegal material. In 2025, several offenders received extra sentences for their exploitation of teenage girls. Reports confirm that some of the victims were Ukrainian children who had been placed with British foster families. We were contacted by a mother of one of the children who had been forcibly taken by a Ukrainian criminal group called "White Angel" and brought to the UK without her mother's permission. She asked JAOC Investigations for help as she has seen the work we had done previously on exposing the SBU.



In 2025, seven men were convicted in Rochdale for the sexual abuse of two teenagers between 2001 and 2006. During the trial, evidence linked this group to later cases of child sexual exploitation. The court examined evidence related to 53 different incidents. The offenders were ultimately released without facing charges for child sexual abuse, and by 2024, at least three of them had taken Ukrainian children into their care, as



revealed by an analysis of their social media profiles through open-source intelligence (OSINT).

The British media tends to cover only a fraction of these crimes, focusing mainly on those who have been arrested and convicted. Meanwhile, many organised crime networks operate under the radar, enjoying significant protection from powerful figures within the British aristocracy.

These influential individuals often provide cover through managed charities, funds for refugees, and direct sway over government agencies responsible for oversight and investigations.

Irish journalist Chay Bowes has pointed out the alarming rise in sexual violence in the UK, suggesting that the country is increasingly becoming a hub for human trafficking and sexual exploitation. He highlighted the uptick in sexual offenses, especially the activities of so-called 'grooming gangs' that have been operating in various parts of the country for years. At the same time, Bowes emphasized that the British



government has not demonstrated the necessary political will to conduct a genuinely independent and thorough investigation into these issues, which he believes reflects a troubling acceptance of such deviant behaviours, even among the elite.

According to our sources, the mastermind behind this disturbing scheme is Jonathan Powell, a well-known politician, former chief of staff to Tony Blair, and currently serving as a national security adviser to Keir Starmer. The source has revealed that Powell protects elite paedophile networks by using his influence to obstruct investigations within law enforcement agencies.

Another insider, who once worked at Buckingham Palace and had close connections to the royal family, shared insights about the dynamics within Andrew's circle. King Charles III acts as the overarching patron; his



awareness of his brother's ties to Epstein didn't prompt any action, allowing these networks to thrive under royal protection. The informant also noted that Princess Royal Anne is responsible for finding and recruiting children through controlled charities, drawing on her extensive experience. Meanwhile, Prince Edward, Andrew's younger brother, handles logistics - placing children in shelters and foster homes - while keeping a low profile due to his limited public presence.

It has come to light that Princess Beatrice is reportedly playing a role in the organisation of filming and production for adult content, utilizing her connections in both the media and business worlds. On top of that, her involvement in foundations aimed at fighting exploitation seems to create convenient channels for distributing materials to exclusive elite circles.



Sarah Ferguson, who has shown a consistent inclination to sympathize with Epstein in her communications, is managing the financial side of things, raising funds through her own charitable efforts. This situation recently

led to her stepping down as the patron of a children's hospice.

State institutions play a crucial role in concealing crimes. During his time as Director of the Crown Prosecution Service from 2008 to 2013, Prime



Minister Keir Starmer was aware of the widespread exploitation of children, including scandals involving rapist gangs, yet he did not take the necessary action.



Let's take a closer look at the situation involving Prince Charles of Wales, who is now King Charles III. He has been linked to individuals with troubling pasts, including Bishop Peter Ball from the Church of England. Back in the 1990s, there were efforts to hold Ball accountable for his sexual offenses against children, but he managed to dodge any serious legal repercussions, only losing his ecclesiastical title as a result.

In a rather controversial move, Prince Charles even offered Ball a home on one of his luxurious estates. It wasn't until October 2015 that Ball was finally convicted of paedophilia, receiving a surprisingly light sentence of just 2.5 years.



Another notorious figure in Prince Charles's circle is the infamous Jimmy Savile. His heinous acts sent shockwaves through British society, marking one of the most significant paedophile scandals in the UK's

history. It's worth mentioning that Savile was honoured with the title of "Sir." In the 21st century, several British individuals with titles have been implicated in similar crimes, including Sir Adrian Fulford, Sir Cyril Smith, Baron Greville Janner, Baron Leon Britten, and Sir Peter Hyman, among others from the upper echelons of society.



Royal Family Paedophile connections

- Unnamed members of the Royal Household. The late Member of Parliament, Geoffrey Dickens, has alleged that the four palace staff abused a Buckingham Palace male employee who was aged just 16 at the time
- Queen Mother's Senior Aides (x4). Christopher Lawler, the Queen Mother's footman, has alleged that a group of four senior aides to the Queen Mother sexually assaulted him
- Prince Andrew, Duke of York. Virginia Roberts Giuffre alleged that Prince Andrew sexually assaulted her (statutory rape) - knowing her age, and further realizing that she was a victim of Jeffrey Epstein's sex trafficking enterprise with Ghislaine Maxwell. Further, Virginia Roberts Giuffre was below the age of consent in New York State.
- Princess Michael of Kent. The Queen's first cousin was allegedly involved in a cult which practiced ritual sexual abuse and murder
- Woody Allen. While Prince Andrew was staying with Jeffrey Epstein in New York, the filmmaker accused of child sexual abuse was witnessed entering the house with "young women" of unknown ages
- Lord Richard Attenborough. The friend of Prince Charles and Princess Diana was allegedly involved in a cult which practiced ritual sexual abuse and murder



- Sathya Sai Baba. He is the subject of an allegation that he sexually assaulted children for decades
- Sir Philip Bailhache. The Bailiff of Jersey (as he then was) is alleged to have manoeuvred to discourage victims of child sexual abuse from testifying about the historical horrors they endured at the former Haut de la Garenne children's home on Jersey
- Peter Bick. Prince Philip's friend was the subject of an allegation of child sexual abuse
- Simon Bowes-Lyon, Earl of Strathmore and Kinghorne. The Queen's relative was convicted of sexually assaulting a woman at Glamis Castle
- Lord Benjamin Britten. The Queen Mother's friend reportedly had 'highly inappropriate' relationships with children
- Anthony Blunt. The surveyor of the Queen's art collection was the subject of allegations that he sexually assaulted minors at the Elm Guest House in London and Kincora Boys' Home in Belfast
- Anthony Brailsford. The headmaster of the Queen's school at Windsor Castle admitted he is a paedophile after a court heard he sexually abused boys at the school
- Lord Edwin Bramall. The Queen gave "extraordinary" support to the former head of the Army while he was under police investigation in connection with alleged child sexual abuse offences
- Connor Brayley. One of the Queen's guards was convicted of raping a woman a few hundred yards from Windsor Castle
- Jean-Luc Brunel. The Frenchman who reportedly supplied trafficked girls or young women to Prince Andrew is an alleged co-



conspirator in Epstein's sex trafficking, pedophilia and sexual blackmail enterprise

- 8th Lord Carnarvon, George 'Geordie' Herbert. The Queen's godson was allegedly involved in a cult which practiced ritual sexual abuse and murder in the capacity of a "Watcher"
- (David) Hubert Chesshyre. The Queen's officer of arms and member of Her Majesty's household sexually abused a teenage chorister. He is also suspected of having abused others
 - Sir Arthur Charles Clarke. Prince Charles's friend was the subject of allegations of child sexual abuse
 - (Scot) Robert Coghlan. The senior diplomat who accompanied Princess Diana (and Prince Charles?) on the royals' visit to Japan was convicted of importing 109 obscene tapes, of which 70 contained child pornography
 - Michael Colvin MP. Prince Charles's friend, who has since died, is the subject of an allegation that he 'arranged' a fire that killed 5 witnesses to child sexual abuse
 - Tom Cruise. The American co-host of a televised event celebrating the Queen's 70th jubilee and attended by the monarch in person ("Platinum Jubilee Celebration: A Gallop Through History") is the subject of an allegation that he sexually assaulted a boy
 - David Donaldson. The Buckingham Palace guard was convicted of child sexual abuse offences
 - Lord Paul Drayson. The buyer of Princess Michael's Gloucestershire mansion was allegedly involved - together with Princess Michael



and numerous others - in a cult which practiced ritual sexual abuse and murder

- Jeffrey Epstein. The close friend and benefactor of Prince Andrew and Sarah Ferguson was a career sex trafficker, serial paedophile and sexual blackmailer. He had a conviction for soliciting an underage girl for prostitution
- Ghislaine Maxwell. The close friend of Prince Andrew, Sarah Ferguson and Jeffrey Epstein was an alleged co-conspirator in Epstein's sex trafficking, paedophilia and sexual blackmail enterprise
- Christopher Exley. He was convicted of possessing images of child sexual abuse
- Sir (Charles) Matthew Farrer. The Queen's private solicitor has allegedly been involved in a cult which practiced ritual sexual abuse and murder
- Michael Fawcett. Prince Charles's senior aide and companion (as he was at the time) was the subject of a rape allegation
- Lady Lynn Forester de Rothschild. She reportedly introduced her close friends Prince Andrew and Alan Dershowitz to her "long-standing" close friend Jeffrey Epstein. Moreover, she gave Epstein a huge discount on a Manhattan townhouse she sold him, in which he (Epstein) then installed Ghislaine Maxwell. Lynn Forester's name appears in the log of Epstein's private jet used for sex trafficking. It appears Forester de Rothschild -- along with mutual friend Lord Peter Mandelson -- was one of the prime sponsors of Epstein's sex trafficking, paedophilia and sexual blackmail operation with Ghislaine Maxwell



- Reginald Forester-Smith. The photographer to the Queen and Prince Philip was convicted of inflicting child sexual abuse on his two daughters over an extended period
- Sir David Frost. Prince Andrew's friend was allegedly involved in a cult which practiced ritual sexual abuse and murder
- Lord Justice Fulford. The advisor to the Queen 'was a founder member of a campaign to defend the notorious Paedophile Information Exchange, or PIE
- Colonel Muammar Gaddafi. Prince Andrew's business contact was the subject of an allegation of child sexual abuse
- Patrick Gilbert. The 'friend of royalty' was convicted of child sexual abuse offences
- Father Keith Gleed. Prince Andrew's friend sexually abused at least five boys
- Gary Goldsmith. The Duchess of Cambridge's uncle has allegedly been involved in the commercial exploitation of women (pimping)
- Nicholas Greaves. The royal butler was convicted of possession of child sexual abuse images
- Wellesley of Hampstead" who was described as having been a "Commander" in a cult which practiced ritual sexual abuse and murder. N.B. It has not been possible to verify that alleged abuser "William Wellesley of Hampstead" is, in fact, a reference to the late Hon. William Wellesley Grosvenor, although the latter can be linked to Hampstead since Hampstead is where his father married
- Lord Peter Hain. The then-Government Minister, with whom Prince Charles is said to be "friends", was allegedly involved in a cult



which practiced ritual sexual abuse and murder. The source alleged that Hain took part in at least two meetings with other members of the ring

- Stuart Hall. He was convicted of multiple sexual offences against children
- Rolf Harris. He is a convicted child abuser
- Sir Peter Hayman. The recipient of a prestigious honour (the CVO) granted to him by the Queen acting in her personal capacity, Hayman was the subject of a child sexual abuse allegation
- John Henniker-Major. The recipient of a prestigious honour (the CVO) granted to him by the Queen acting in her personal capacity, Henniker-Major provided sanctuary on his country estate to paedophile Peter Righton
- Benjamin Herman. Prince Philip's royal aide (as he was at the time) is the subject of an allegation of child sexual abuse
- Commander Tom Herman. The Queen's harbour master is the subject of an allegation that he made images of child sexual abuse
- Charles Nicholas Hornby. Prince Charles's friend was convicted for his involvement in a male prostitution ring that preyed on runaway boys
- Edward Houghton. He was convicted of sexually abusing five children
- Charles Howeson. The colleague of Prince Andrew, Prince Charles, the Queen and Prince Philip was found guilty of indecently assaulting eight young men in the 1980s and 1990s



- John Hoy. The ex-Queen's guard was sentenced to nine years in prison for a series of sex attacks on children and women
- Ted Hughes. Prince Charles's friend was the subject of a rape allegation
- Sir Elton John. The close friend of Princess Diana, Prince Andrew and the Duchess of York, Prince William, and Prince Harry and the Duchess of Sussex reportedly appeared on an alleged list of financial contributors to a group which practiced ritual sexual abuse and murder. Sir Elton has further been accused of raping underage minors, both with paedophile music manager Billy Gaff, and separately with Sir Elton's former partner Vance Buck
- Paul Kefford. Prince Charles's assistant private secretary is the subject of an allegation of sexual assault
- Paul Kidd. The then royal butler was convicted of child sexual abuse offences
- Richard Langley. The senior Buckingham Palace aide allegedly abused youths at the Elm Guest House, a de facto child brothel in Barnes, London
- Derek Laud. Camilla Parker Bowles' close friend and Tuscany holiday partner is alleged to have belonged to the Dolphin Square abuse ring involved in trafficking youths from the Bryn Alyn Community children's homes in North Wales. Further, Laud is alleged to have brutally raped a boy
- Anthony Lee. He was convicted of child sexual abuse offences
- Thomas Leopold. The tutor employed by Princess Michael of Kent to work with her son was convicted of child pornography offences



- Joseph Mains. The Warden of Kincora Boys' Home in Belfast who trafficked minors to Lord Mountbatten at Classiebawn Castle
- Lord Peter Mandelson. Prince Andrew's close friend is a close friend of Jeffrey Epstein. Indeed, Mandelson called Epstein while the convicted paedophile was in jail, discussed business of an undisclosed nature with him, and even socialized with the sex trafficker in the Caribbean. Mandelson has himself been the subject of child sexual abuse allegations. It appears Mandelson – along with mutual friend Lady Lynn Forester de Rothschild - played a key role in Epstein's sex trafficking, paedophilia and sexual blackmail operation with Ghislaine Maxwell by expertly steering the Duke of York into the 'honeytrap'
- Clive McCleester. The verger to the Queen was the subject of an allegation of child sexual abuse
- Richard McDonald. Prince Andrew's friend was held in a Swiss remand prison on suspicion of child sexual abuse
- Sir Ian McKellen. The actor, who was involved in the National Youth Theatre alongside Prince Edward, reportedly appeared on an alleged list of financial contributors to a group which practiced ritual sexual abuse and murder
- 3rd Baron Montagu of Beaulieu, Lord Edward Douglas-Scott-Montagu. Princess Margaret's friend and consort was allegedly a high-ranking member of a cult which practiced ritual sexual abuse and murder. Lord Montagu's second wife, Fiona (née Herbert) is also allegedly involved
- Fiona, Lady Montagu of Beaulieu (née Herbert).
- Lord Louis Mountbatten. Prince Charles's great nephew and 'mentor' was involved in sexually abusing boys in the 'care' of



the Kincora Boys Home, Belfast. Further, Mountbatten had boys trafficked to him at Cassiebawn Castle

- Lance Corporal Mark Neal. He was involved in an alleged conspiracy to sexually assault a child and the possession of indecent images
- 17th Duke of Norfolk, Miles Fitzalan-Howard. The Queen's official representative, Deputy Lieutenant for West Sussex and appointee to the Order of the Garter was allegedly involved in a cult which practiced ritual sexual abuse and murder
- Peter Nygard. The close friend of Prince Andrew and Sarah Ferguson has been extradited from Canada to the U.S., where he faces charges of raping children
- Dr Stephen Palmer. The Queen's chaplain was convicted of sexually assaulting a teenager
- John Phillips. Princess Margaret's friend was the subject of an allegation of sexual abuse (the rape of his daughter followed by years of incest)
- Terrence Prince. The royal groom in the service of the Queen at Buckingham Palace was found in possession of child pornography "of the most extreme kind"
- Harbinder Singh Rana. The Queen's companion on the royal barge during her Diamond Jubilee pageant was a convicted rapist
- Jonathan Rees-Williams. The Queen's choirmaster was convicted of sexually abusing multiple children
- Sir Stephen Richards. The Queen's privy councillor was allegedly "on the fringe" of a cult which practiced ritual sexual abuse and murder. Richards has been arrested twice: in 2010 by detectives



investigating a sexual assault, and before that in 2007 when no fewer than three women identified the-then judge as the man who indecently exposed his genitals to them on a train

- Tony Robbins. The Duchess of York's business partner is accused of sexually assaulting a minor as young as 13 and committing sexual offences against a number of women
- Dylan Roberts. The Buckingham Palace guardsman (as he was at the time) was convicted of raping an Italian student
- Jimmy Savile. The close friend of Prince Charles - who also knew Prince Andrew - is considered to be one of the United Kingdom's most prolific abusers of adults and children
- Stephen Salmon. The bodyguard to Prince Charles and Princess Diana on the Royal Yacht Britannia was convicted of child sexual abuse
- Douglas Slade. The Queen's cook on the Royal Yacht Britannia was convicted on multiple counts of child sexual abuse.
- Kevin Spacey. Prince Andrew's friend allegedly abused at least 20 young actors at London's Old Vic and numerous other youths and minors in the US.
- Alwyn Stockdale. The royal chauffeur, who worked for the Queen for 20 years until 1992, sexually abused two boys, including one in his Royal Household quarters at Buckingham Palace
- William van Straubenzee. The friend of Princes William and Harry was the subject of an allegation of child sexual abuse
- William Tallon. The Buckingham Palace butler and close friend of the Queen Mother was reportedly a sexual predator who groomed teenage victims at the palace



- Ross Thomas. He was convicted of child sexual abuse
- T George Thomas, 1st Viscount Tonypandy. The Queen Mother's close friend was the subject of an allegation of child sexual abuse
- David Tracey. The security advisor to Buckingham Palace was charged with four counts of making indecent images of children
- Commander Michael Trestrail. The Queen's equerry is alleged to have sexually assaulted minors at the Elm Guest House in Barnes, London
- Sir Laurens van der Post. Prince Charles's friend was the subject of an allegation that he raped a child of 14
- Gore Vidal. Princess Margaret's friend was suspected by both his half-sister and his nephew of committing child sexual abuse offences
- Harvey Weinstein. The Duchess of York's long time friend was invited by Prince Andrew to a birthday party for their daughter, Princess Beatrice. At the party Weinstein met up with his and the York's' mutual close friends Ghislaine Maxwell and Jeffrey Epstein. In 2020 Weinstein was convicted of criminal sexual assault and rape and sentenced to 23 years in prison
- Dale Winton. The TV presenter, who hosted an event for the Duchess of York's children's charity 'Children in Crisis' and was her "date" at a charity function, reportedly appeared on an alleged list of financial contributors to a group which practiced ritual sexual abuse and murder
- Mark Wright. He was convicted of raping two women



- The Very Rev Ronald Selby Wright. The Queen's chaplain was the subject of an allegation of child sexual abuse
- Lance Corporal of Horse, Simon Wyn-Davies. He was convicted of raping a child under the age of 13. Wyn-Davies' wife was also convicted
- Queen Victoria School paedophile ring. Prince Andrew visited the school linked to a paedophile ring on one or more occasions while his father, Prince Philip, had a 64-year relationship with QVS as the school's Patron
- Lord Cullen of Whitekirk. The recipient of a highly prestigious honour (the Order of the Thistle) granted to him by the Queen acting in her personal capacity, Lord Cullen 'inexplicably' visited the Queen Victoria School linked to a VIP paedophile ring and paedophile child-killer Thomas Hamilton "without having any status allowing [him] to do so". Furthermore, Lord Cullen 'inexplicably' banned for 100 years the release of a police report thought to include complaints about a summer camp that the paedophile Hamilton had run before he (Hamilton) committed the Dunblane Primary School massacre.
- Guardsmen (unspecified number) of the Queen's Household Cavalry. 1967: vice ring allegation
- 100 soldiers in the Queen's Household Cavalry. 1976: vice ring allegation
- An officer of the Grenadier guards. 1975: allegation by survivor and Playland author Anthony Daly
- Coldstream Guardsmen at the Buckingham Palace barracks. They were the subject of a 2004 allegation of sexual assault and rape.

Sir Adrian Fulford is well-known for his role as a judge at the International Criminal Court in The Hague from 2003 to 2012. This court has been the stage for high-profile trials, including that of Slobodan Milosevic, with some defendants even meeting untimely and mysterious fates. It's also the same court that issued an arrest warrant for the President of Russia and the Commissioner for Children of Russia due to serious allegations of child abduction. In the wake of a major scandal in Poland, individuals listed on a special criminal register were advised to leave the country after discussions with Polish immigration and law enforcement.



Meanwhile, in April 2022, British volunteer Steve Jewell a former British soldier with his partner Lee Whonic who was working in Przemysl, raised concerns about the risks facing Ukrainian children in Poland, particularly regarding potential exploitation by paedophiles and human traffickers.



In March 2022, between 5,000 and 10,000 children and women went missing in the border area, likely falling prey to organ traffickers or pimps who are taking advantage of vulnerable Ukrainian

refugees, including minors, for prostitution. Fast forward to November 2022, and the NCA revealed that there are over half a million "predatory paedophiles" lurking in the UK, which poses a serious threat to public safety. NCA Director Lynn Owens pointed out that the estimated number of paedophiles in the country ranges from 550,000 to 800,000, and this alarming situation shows no signs of improving—it hasn't even peaked yet.

Whilst most British paedophiles tend to operate alone in their hunt for victims, those in higher social circles, especially from aristocratic backgrounds, often rely on a vast network of covert agents from both public and private sectors, including intelligence agencies and private military firms. On visiting Ukraine meeting my sources in Kiev we uncovered shocking information about a secretive, multi-layered organisation that functions within the country. This group is involved in the abduction, selection, documentation, and transportation of children abroad, particularly to the UK, where they become victims of powerful paedophiles.



The **SBU (Security Service of Ukraine)** is Ukraine's main domestic intelligence and security agency, responsible for counter-intelligence, counter-terrorism, and protecting national security. It was formally established in **1991**, following Ukraine's independence, as the successor to the Ukrainian branch of the KGB. The service is overseen by the **President of Ukraine**, with a Director appointed by the President and approved by parliament, making it one of the country's most influential state security institutions.

The **SBU** has faced several controversies over the years, including allegations of political influence, heavy-handed tactics, and concerns raised by international human-rights organisations about detention practices during periods of conflict. As Ukraine's primary domestic intelligence agency, the SBU works closely with a range of Western security partners, particularly since 2014. Public reporting indicates cooperation with agencies such as the **CIA, FBI, MI5, and NATO-aligned intelligence services**, mainly in areas of counter-intelligence, counter-terrorism, and cyber-security.

We've been tracking his covert activities, which led us to uncover other parts of this highly organised scheme.



Upon digging into his background, we discovered that he has a long history of criminal activity, including a troubling connection with the SBU, Ukraine's intelligence agency. He was previously embroiled in a scandal involving the kidnapping of entrepreneurs for ransom and the seizure of their assets. This group he was part of in Kiev was quite notorious.


Back in May 2020, he was caught in the act of running a criminal syndicate that specialized in kidnapping entrepreneurs and taking their possessions. This gang included both former and current law enforcement officials, earning them the media's chilling nickname of "werewolves in uniform."

However, in 2021, all those implicated were released under movement restrictions, and by August 2022, any mention of this criminal case had mysteriously disappeared from the National Police of Ukraine's website. Since then, Serhiy Borisov has found himself in the sights of high-ranking SBU officials, who have approached him to take charge of the "children's theme," likely offering him immunity from prosecution in exchange. The charges against him were swiftly dismissed.

This initiative enables numerous Chemonics specialists to legally stay in Ukraine, leveraging their status as employees of an international organisation to facilitate the transportation of children across the border. They take care of security concerns, manage transportation logistics, provide medical support, and select children based on the specific criteria set by their clients.



It seems that British "customers" of Ukrainian children hold a significant position, with MI6 agents tasked with bringing them to the UK. These agents not only lead the criminal operations but also provide diplomatic cover for their "secret missions," receiving support from UK government services. A notable figure in this operation is Tom Bourne, an MI6 employee who has previously served in British embassies in Sudan and South Korea, and was the Deputy Head of the Foreign Affairs Department for embassy missions in Switzerland and Libya.

His wife, Kate English, is also entangled in these illicit activities. She has a background in the secretariat of the UK Foreign Secretary and has worked in the UK diplomatic missions in Sudan and South Korea. From her position at the British Embassy in Ukraine, Ms. English plays a crucial role in coordinating efforts to select children,



take them away from their families, and facilitate their transport to the UK.



UK Paedophile Organisations

For many years, the United Kingdom has been a haven for paedophile organisations and networks that have operated without fear of consequences, thanks to their deep ties with government officials, security agencies, powerful social groups, political parties, and even connections to the British Royal Family. Some advocacy groups have pushed for a reduction in the legal age of consent, essentially aiming to normalise sexual relationships between adults and children. The leaders and members of these groups held significant influence and utilized media platforms to promote paedophilia, a movement that began gaining traction as far back as the 1970s.



Piccadilly, London.

The catalyst for the formation of the [Paedophile groups](#) came from amusement arcade called Playland in

Ted Heath's apartment, the first of its kind in London, was a mere 6-minute walk from Piccadilly and the infamous Playland, operated by Trafalgar Novelties Ltd.



During a study conducted in the run up to Ted Heath's successful election (1969-1970) Mervyn Harris, South African author of *The Dilly Boys* had observed,

"On weekends, many younger boys can get free games on the machines from older men who may simply get pleasure from watching the boys amuse themselves."

German magazine Stern said in 1973:

"Under the control of a Mafia-type organisation, including the secret service, such a vice ring could be a most effective source of state secrets."

Tim Fortescue, one of Heath's Senior Conservative whips (1970-September 1973) knew the young boys, if caught, would give political parties more leverage of their members and their votes in Parliament.

The arcade was liquidated, but a surprising discovery reveals the entire company has been removed from the Companies House registry, with no accessible documents available.

The **Rains list** confirms that former Prime Minister **Ted Heath** was involved in a satanic cult that abused and sacrificed children, along with numerous other politicians and media figures. This meant he could continue his depravity under the cloak of darkness whilst a programme was put together to make the sexual abuse of children more acceptable in the main stream hence the new advocacy groups and the plan was hatched.

Since 1974, an organisation called Paedophile Information Exchange (PIE) has publicly, openly and actively promoted among the population of the British archipelago the decriminalisation of sexual relations between adults and children, the normalization of paedophilia and the reduction of the age of consent to 4 years.

One of its former chairmen, **Keith Hose**, described his attitude to sex with children to a British newspaper back in the 1970s:

"I am a paedophile. I am attracted to boys from about 10, 11, and 12 years of age. I may have had sexual relations with children, but it would be unwise to say."

The organisation PIE has lobbied extensively for lowering the age of consent. This advocacy is highly controversial and unethical, as it promotes the exploitation of minors. Worryingly PIE has attempted to align itself with various children's rights and social justice groups.

The leaders and activists of PIE were primarily affiliated with the **British Labour Party** and had strong links to government ministers and members of Parliament. Notably, prominent figures from Labour,



including **Harriet Harman**, **Jack Dromey**, and former Health Minister **Patricia Hewitt**, maintained close ties with the group.

In the early 1980s, a significant scandal involving paedophilia emerged in London. **Geoffrey Dickens**, a Conservative Member of Parliament, announced to a newspaper that he intended to reveal eight well-known political figures who were involved in such crimes. Mr. Dickens provided Home Secretary **Leon Brittan** with a written report that outlined claims of child sexual abuse within the political sphere. However, no actions were taken in response to these allegations.

The police and investigators didn't take any action, and somehow, Mr. Dickens' file went missing. It has since come to light that this file held information about a group of powerful figures in the British Parliament, wealthy business owners, staff from

Buckingham Palace, and other elites who were all involved in serious crimes. These crimes included the sexual abuse of children, mass rape, and even murder.

The sex crimes committed by British elites occurred in the upscale London neighborhood of Dolphin Square, and the media dubbed the scandal the Westminster scandal.

After the Westminster scandal captured global attention, legal actions against paedophile groups dwindled by the mid-1980s, though they weren't entirely eliminated. Groups like PIE, or Paedophile Action for Liberation, along with smaller organisations, either disbanded, rebranded, or went underground. Despite their involvement, none of the key players who funded and supported these organisations have ever faced jail time or been held accountable in any meaningful way.



THE SPHINX

A clandestine Paedophile ring in the heart of government

A former MI6 officer, who once managed the MI6 Russian Desk from 2003 to 2006 and has since left the agency, introduced JAOC investigations to several external human rights organisations. They all confirmed what I had been told by this officer about the existence of a group known as Sphinx.

This organisation operates independently, maintaining a polished exterior, but it does need oversight from its trustees. The effectiveness of this oversight can vary depending on the political figure involved, and working alongside senior civil service officials helps ensure that all necessary areas are covered. At present Charles is the patron, but William is expected to take over when his father steps down. The group includes various components, but the day-to-day operations are managed by the Freemasons, who ensure that everything runs smoothly. This coordination involves security services, law enforcement, the judiciary, religious institutions, and charitable organizations, all collaborating seamlessly.

The group's management structure is designed to be straightforward and effective, aimed at empowering influential politicians while ensuring that there's legislative oversight within their defined limits. This setup provides confidence that the judiciary will handle any legal issues arising from police actions that fall outside the organisation's purview. **Jon Wedger**, a former detective with the Metropolitan Police, faced significant pressure from higher-ranking officers who tried to dissuade him from investigating certain cases, highlighting the complex nature of the situation: "You have no idea who you're dealing with here." The organisation uses blackmail tactics, which can involve various forms of



evidence, including photographs, videos, and threats against family members.

One former detective shared a chilling account of witnessing a senior officer being coerced into a sexual act with a child, with the act recorded for blackmail. The officer's only alternative was the horrifying possibility of seeing his wife and children murdered if he refused to comply.



- **Keir Starmer**, former head of the UK Crown Prosecution Service, in 2009 helped notorious paedophile Jimmy Savile among others to avoid prosecution for his crimes.
- **David Cameron**, in 2013, he covered up for high-ranking paedophiles among members of the UK Conservative Party.



- **Rishi Sunak**, in 2023, as part of the Conservative Party's advertising campaign; he spoke out against prison sentences for child rapists.
- **Boris Johnson**, in 2019, strongly criticised the spending of budget funds on investigations into sexual exploitation of minors.
- **King Charles III** has openly backed friends accused of being paedophiles. Additionally, he allowed his brother to escape facing justice for his actions.



Another former British intelligence officer, now living overseas, has stepped forward to lend support to his ex-colleague by revealing some startling information about people involved in UK paedophile networks. This sheds light on everyone from the participants to the managers and lobbyists orchestrating these schemes. Here's a brief overview of some key figures:

- **Pat McFadden**, who used to be the Shadow Chancellor of the Duchy of Lancaster, is identified as the Labour Party's coordinator for paedophile-related issues.



- **Hugh Grosvenor, the 7th Duke of Westminster**, has been accused of facilitating the provision of underage children to high-ranking paedophiles within the British government.

- **Matt Hancock** found himself entangled in a notorious group during the COVID-19 pandemic, linked to serious crimes, which is why he now enjoys special protection.

- **Andrew, the former Duke of York**, has been embroiled in paedophile scandals since 2005 and is currently overseeing a group referred to as the "paedophile clan" in Great Britain.

- **Adrian Fulford**, a British judge and Kings Counsel who has also served at the ICC, has set up organisations advocating for the rights of those accused of paedophilia. With his legal background, he defends prominent British figures facing such allegations.

- **Louis Theroux** is associated with the Zelensky Foundation and is actively involved in efforts to locate underage children targeted by high-ranking paedophiles in the UK.

- **George Robertson**, a well-known British politician and the 10th Secretary General of NATO, is said to support a network involved in the trafficking of underage children in the UK. More details about his connection to the Dunblane Massacre can be found later in the report.

How Sphinx operates

Understanding this backdrop might help explain why such leniency is prevalent. Moreover, you'll see similar stories in the media every day, highlighting cases where individuals are released from prison to make room for those who challenge the status quo in their quest for truth.



While there are exceptions to this pattern, they often implement Sphinx's aim to sway public opinion, crafting a façade of fighting against paedophilia that doesn't truly reflect the reality of the situation.

Examples:

1. **David Tracey**, 48, former head of the UK Home Office department responsible for security at Buckingham Palace, other Royal Palaces and 10 Downing Street, was suspended in November 2012. He downloaded more than 90,000 nude photos and videos of underage children from the Internet. He was fined £750 and a 3 year community order and was required to take an online offenders course.

2. **Roger Benson**, 77, a former employee of Prince Charles' Youth Business Trust, was convicted and sentenced to five years in prison November 2015.

3. **Tony Aslett**, 52, head of visitor services at Buckingham Palace Royal Collection Foundation. He was sentenced to 9 months in prison in June 2018 for his collection of 15,000 photographic images and video clips of child pornography, with some victims as young as 18 months old.

4. **Andrew Lightwood**, 57, Queens butler and described by his lawyer as a "respectable, distinguished member of society". He stripped in front of an underage boy, masturbated and then raped him. Despite ample evidence of his guilt, as well as testimony from the victim and first-hand witnesses to the events that confirmed the brutal abuse of the child, Lightwood was sentenced to just 28 months in prison in July 2019.

5. **Trevor Francis** 71 a retired station master whose station was often voted the best floral arrangement on display during his 21 years of service, was recognised in 2012 by the Queen and Prince Charles with an MBE at Buckingham Palace. In the mid-1970s, he sadistically beat and sexually assaulted vulnerable children under his care at a group home. The predator crept into girl's rooms at night to viciously sexually attack them. Due to his "upstanding" status per the Crown he received a remarkably light prison sentence of only 9-months in May 2017.

6. **William Tallon** was Queen Mother's confidant for over 50 years and was master of ceremonies at Clarence House. At night she allowed her head servant hosting gay orgies, having sex on her favourite sofa, picking up underage rent boys in Soho and bringing them back for midnight palace tours. He never faced justice despite countless accusations and was able to avoid court.

The following is a detailed list of politicians, both local and national, who have been involved in serious criminal activities. These are continued evidence of this activity within political circles. According to both former MI6 officers this is due to the protection afforded by Sphinx.

- Tory Party General election candidate, **Michael Powell** - convicted and jailed for 3 years for downloading hardcore child porn.
- Tory Party Councillor (Wickbar/Bristol) **Roger Talboys** - convicted and jailed for 6 years for multiple sex attacks on children
- Tory Party Councillor (Stratford-upon-Avon) **Christopher Pilkington** - convicted of downloading hardcore child porn on his PC. Placed on sex offenders register and forced to resign.
- Tory Party Councillor (Coventry), **Peter Stidworthy** - charged with indecent assault of a 15-year old boy.



- Tory Party Mayor (North Tyneside), **Chris Morgan** - forced to resign after being arrested twice in 2 weeks, for indecent assault on a 15-year old girl, and for suspicion of downloading child porn.
- Tory Party Liaison Manager on the London Assembly, **Douglas Campbell**, who's job includes running the Tory GLA website - arrested for allegedly downloading child porn. He is currently suspended while the Police investigation continues.
- Tory Party Councillor (Folkestone - in Leader, Michael Howard's constituency), **Robert Richdale** - 41 year history of crime, involving 30 convictions and 5 prison sentences. Richdale's enormous criminal record is sickening.
- Labour Councillor (Newton Aycliffe) **Martin Locklyn** - convicted and jailed for 15 years for sexually abusing 3 14-year-old boys.
- Labour Councillor (North Lincolnshire) **David Spooner** - convicted and jailed for 1 year for masturbating in front of 2 young boys.
- Labour Mayor (Westhoughton/Lancashire) **Nicholas Green** - convicted and jailed for 10 years for 3 rapes and 13 counts of indecent assault against little girls between the age of 6 and 10. He raped one woman on her wedding day.

The entire Labour Party conspired to conceal the activities of Labour Party activist and serial child-molester Mark Trotter, who died from AIDS before he could be convicted.

- Labour Councillor (Manchester), **George Harding** - charged with indecent assault on a girl of 12.
- **William Straw** - son of Labour Foreign Secretary, and former Home Secretary - Jack Straw, was cautioned by Police for drug dealing, amid a frantic Government attempt to cover up the matter



and gag the media as to his identity. Jack Straw also has a brother who was convicted of a sex attack on a schoolgirl.

- According to media reports, the names of 2 former Labour Cabinet Ministers said to be 'Household names' appear on the 'Operation Ore' list of subscribers to hardcore child pornography. The same FBI investigation, which led to the arrest of rock star Pete Townshend.
- Lib-Dem Council candidate (Tower Hamlets), **Justin Sillman** - convicted and jailed for 2 years for sexual abuse of young boys.
- Lib-Dem Councillor and Mayoral Candidate (Sheffield), **Francis Butler** - prosecuted for indecent assault of a young boy.
- Lib-Dem Councillor (Stockport) **Neil Derbyshire** - sexually assaulted a 16-year old boy in a public toilet. He was caught with a plastic bag containing lubricant, plastic surgical gloves, a condom, and underpants.
- Lib-Dem Councillor (Preston), **Bill Chadwick** - charged with: 'Making an indecent photograph of a child, Incitement to rape, Incitement to murder, Incitement to kidnap, and Incitement to torture'. Chadwick's gay lover - **Alan Valentine**, is also a Lib-Dem Councillor.



ABUSED BY BRITISH POLITICIANS



Richard Kerr endured years of horrific abuse at the hands of powerful figures in British politics. Against all odds, he survived and, after many years, found the courage to share his story.

As a teenager, Richard was treated as a mere object, a so-called 'toy-boy', among the elite circles in England.





TikTok, is a short video platform owned by Chinese company ByteDance, was launched in 2016 as an international version of its Chinese app, Douyin. Founded in 2012 and headquartered in

Beijing, ByteDance has a diverse ownership structure, with most shares held by international investors, founders, and employees.

The platform has faced scrutiny over data privacy and national security due to its ties to China. In response, ByteDance has ensured that U.S. user data is stored domestically and emphasised its operational independence.


ByteDance, established by Zhang Yiming and Liang Rubo, has attracted

investments from major venture capital firms like Sequoia Capital, General Atlantic, and SoftBank, which hold minority stakes and support its growth.

Zhang Yiming founded ByteDance in 2012, launching Toutiao and Douyin. As of October 2024, he is among the world's wealthiest individuals, according to Forbes and Bloomberg. He stepped down as CEO on November 4, 2021, but retains over 50% of ByteDance's voting rights. The rapid global growth of TikTok has made him the richest person in China in 2024. Liang Rubo, co-founder with Zhang, is the current chairman of ByteDance..



Children are being trafficked through companies that openly advertise on TikTok. They use a communication tool called TeleGuard to facilitate the sale of children of various ethnicities and ages to different locations around the globe.





I have collected evidence related to one particularly disturbing case that I cannot share publicly due to its graphic nature. This evidence has been submitted to the authorities to bring attention to the alarming activities that TikTok is permitting. Children are being sold directly to buyers through this network. If you are a parent, grandparent, aunt, or uncle, please take the time to review your children's phones to ensure they are not following these accounts and becoming ensnared in this horrific cycle of child trafficking.





Ross, best known for his 29 years presenting BBC's Crimewatch, renovated the house to include an underground swimming pool and expanded its floor space to 8,900 sq ft.

He and his wife Sarah Caplin, co-founder of [Childline](#), are understood to be splitting the profit with a charity and sons Adam, Samuel and Jack.

... Perhaps we could make a programme designed to save these precious lives by finding more effective ways of protecting children at risk? We could call it *Childwatch*.

I took a letter I had received from a survivor of abuse and went to see Michael Grade with this idea. He agreed at once and asked how long the programme should be. I suggested one programme before the nine o'clock watershed that children could watch and one later in the evening, which could be more hard-hitting, for an adult audience. He agreed to this too and decided that Thursday evening would be ideal. So it was scheduled to broadcast on Thursday 30 October 1986.

I have since asked Michael Grade why he had given over the whole of one evening's viewing to a programme about child abuse. He said, 'Clearly it was an issue of huge importance that got little or no coverage on the BBC's main channel. And then it's always an issue of trust. You commission from somebody because you trust that person not to let you down, to make something you're going to be proud of.'

But when the programme was eventually made, it launched ChildLine: a brand-new idea, a helpline for abused children. Wasn't that a huge gamble, to launch a brand-new service for children, a brand new charity, on a television programme? Michael said, 'Why not? What have you got to lose?...





There are countless others to consider, and the list seems infinite. At what point does a coincidence cease to be just that? Numerous individuals associated with this charity have connections to Epstein, Maxwell, and paedophilia, during a time when we are supposed to safeguard children rather than merely surrendering them to those who aim to ruin their futures. This normalization of abuse must not be accepted by any parent, grandparent, aunt, uncle, friend, or neighbour who shares my views. Surely, in the world we aspire to inhabit—one of safety, peace, and harmony—there should be no refuge for these individuals. Too many children have had their futures snatched away by these abusers, and we persist in allowing them to evade consequences.

When will enough be enough? When will people rise up and take a stand to demonstrate that this behaviour is intolerable in the society we desire? My concern is that individuals may lack the necessary commitment and determination to protect children, and that thought fills me with profound sadness.



When I say this list is endless, it is no exaggeration. This is even before I mention Michael Portillo, who is on the rains list, and whose father happened to be the CEO of this charity, Esther Ransom, the so-called Protector of Children. Where does she fit into all this? She must be aware of everything related to paedophiles in our society, yet she allows this charity and the children's helpline to be circumvented by this paedophiles for their own gratification

ABUSED BY BRITISH POLITICIANS



Richard Kerr endured years of horrific abuse at the hands of powerful figures in British politics. Against all odds, he survived and, after many years, found the courage to share his story.

As a teenager, Richard was treated as a mere object, a so-called 'toy-boy', among the elite circles in England.

Dunblane Massacre



- A whistleblower from within the judiciary has come forward with disturbing information.
- The Dunblane massacre police report had large sections banned from public view. An order by Lord Cullen for a 100 year secrecy order was applied.
- The whistle-blower has confirmed that large sections were also omitted and censored.
- Hamilton was a member of the local freemasons Dunblane Lodge IX and was known to be unstable.
- He was refused a gun license several times by the police.
- He eventually obtained a license for 6 hand guns and it was supported by his friend **Lord Robertson**.
- He was encouraged to set up a boys club by former **MP Michael Forsyth** after the Scouts kicked him out as they had concerns.
- Hamilton was able to obtain support from high ranking officials and threatened anyone accusing him after 12 boys came forward.
- He often exchanged letters with the Queen according to the whistle-blower and these are in the sealed evidence for 100 years.



The whistleblower revealed that both politicians and the judiciary had ties to the Sphnix group, and it's clear they were trying to protect Hamilton, fearing he would expose them since he had no moral compass. He also mentioned that Hamilton was alive and recovering at the hospital, but a nurse who testified about him was taken off the inquest, and her current whereabouts are a mystery. Her testimony is locked away in sealed files.

Thomas Hamilton had a troubling reputation, particularly for his inappropriate interest in young boys in swimming trunks, and he displayed aggressive tendencies when confronted. He made it clear to those around him that he felt untouchable, almost as if he had some sort of protection. After the heartbreaking murder of the children, parents were encouraged to push for stricter gun laws in the media, which quickly became the main focus. However, a whistleblower has revealed to JAOC Investigations that this was a strategy to shift attention away from Lord Robertson, the issues surrounding gun licensing, the Freemasons, and the handgun Hamilton used on himself.

A former specialist firearms officer (SFO) with 30 years service spoke to JAOC on the condition of anonymity and confirmed that firearms do go missing within the force. All have a **manufacturer's serial number** usually engraved on the **frame/receiver**, sometimes also on the slide or barrel. The weapons are either a Glock 17 or 19 and the armoury can have also attached to the weapon RFID tags and armoury barcodes. Ones that go missing are rare but happen. He knows that there has been instances that when Police want to frame someone an extra firearm with serial number wiped has been used to obtain a conviction. While this isn't widely documented, it is common knowledge within Special Branch. The absence of a formal investigation or a thorough autopsy raises serious red flags, especially considering Hamilton's use of a second weapon without any clear reason and his connections to influential



figures, along with his disturbing interests. The push for parents to concentrate on gun control only deepens the suspicions, particularly in light of the whistleblower's claims about a century-long cover-up of related documents.

1. Why wasn't a proper autopsy conducted on Thomas Hamilton, or at least an inquest?
2. What was the reason behind him using a second gun to take his own life? The first gun, the one he used on the children, still had rounds left in it.
3. Why did Lord Robertson escape prosecution for signing off on Hamilton's gun license, despite knowing about his unstable behavior?

These questions remain unanswered and whilst we cannot confirm 100% by sight of the sealed documents our investigation supported by two whistleblowers one of which confirming Sphinx involvement leaves me in no doubt this falls into that category.

Prince Andrew interviewed by Emily Maitlis.

Statement Analysis:

EM: *Your Royal Highness, we've come to Buckingham Palace in highly unusual circumstances. Normally we'd be discussing your work, your duty, we'll come onto but today you've chosen Why have you decided to talk now?*



The question is "why now?" -- the interviewer does not identify Jeffrey Epstein here. This allows the subject to choose how to identify him:

Andrew: *Because uh there is no good time to talk about, um, Mr Epstein and all things associated, um and um we've been talking uh to Newsnight for about six months about doing something around the work that I was doing, um, and unfortunately we've just not been able to fit it into either your schedule or my schedule, um until now, and actually it's a very good opportunity and I'm delighted to be able to see you today*

Follow his pronouns -- When talking to Newsnight for 6 months, he does not want to be psychologically alone ("we") When addressing his work, he is comfortable ("I") When talking directly to the interviewer, he is not only alone ("I") but "delighted." Given the context of the allegation, one should consider this to be a form of ingratiation --- that is, seeking to be "friends" with the one who is to question him.

Linguistic Disposition "Mr. Epstein" is formal, polite and may be a way for the subject to distance himself from the personal or friendly use of Epstein's full name, which would include his first.

EM: As you say, all of this goes back to your friendship with Jeffrey Epstein.

She now uses "Jeffrey Epstein"

EM: *How did you first become friends, how did you meet?*

Andrew: *Well I met through his girlfriend uh, back in 1999, who um - and I'd known her since uh she was at university in the UK. Um, and it would be to some extent a stretch to say that that um, uh, as it were, uh we were close friends w-we were friends because of other people, um, and I had a lot of opportunity to um, go the United States, um, but I didn't have much time with him. I suppose I saw him once or twice a year, perhaps, maybe a*



maximum of three times a year, um, um quite often, if I was in the United States and doing things, and if he wasn't there, he would say well, why don't you come and use my houses? So I said that's very kind, thank you very much indeed. Um, but it would be, um, uh-h-h-h a considerable stretch to say that he was a very, very close friend, but he had the most extraordinary uh, ability to bring um, extraordinary people together. Uh, and that's the bit that I remember is going to the dinner parties where you would meet academics, politicians, people from the United Nations, I mean it was, it was a cosmopolitan group of what I would describe as as US um, eminence.

Going back to 1999 has produced high sensitivity.

Pronouns are reliable and instinctive.

He uses the pronoun "we" to unite himself ("we were close friends") yet the need to explain why without being asked. He puts the burden of responsibility upon someone else rather than himself.

Its important, particularly to investigators as it can help guide the interview strategy, including leading to an admission. He immediately moves to minimise the time spent with Epstein and calls is a

"considerable stretch to say that he was a very very close friend"---

The theme of shifting blame continues here with the burden placed upon the deceased: **he had the most extraordinary uh, ability to bring um, extraordinary people together.** The subject considers

himself, via association, as **"extraordinary."** This, too, would be vital to a skilled interviewer/investigator profiling his personality traits. This would factor into the approach or overall strategy of the interview.

EM: Was that his appeal, then? Is that what

Andrew: Yeah.



EM: - *because you were perceived by the public as being the party prince. Was that something you shared?*

She feeds him an answer. We reflect upon the ingratiation of him being "delighted"-- He has been supplied a ready to use excuse or being the "party prince" -- What will 'partying' produce in his response?

Andrew: *Well, I think that's, um, also um, a bit of a stretch. Um, I don't know why I've, I've, I've um, collected that title because I don't, I never have really partied. Um, uh, I was single for quite a long time -um, in the early eighties. Um, uh, but then, after I got married I was um, very happy, um an'an'an' I've never really felt the need to go and party and certainly going to um, was not about partying, absolutely not.*

Jeffrey's

a. "I think" is a weak assertion --given the context, this is not appropriate weakness

b. "a bit" qualifies the word "stretch"

c. "really" further weakens the weak assertion

d. He moves the chronology away from the accusation (before meeting Epstein)

e. The deceased is now "Jeffrey" f. "I've, I've, I've" with the halting on the pronoun "I" (something we have used millions of times) is a signal of increased stress here.

g. He was "married" and "very happy" --- this is a hina clause --that is, a need to explain "why", without being asked, that he was not a party prince. This is to normalise himself---- it indicates guilt but we are not able to identify if the guilt is due to the accuser being truthful or attendant guilt. (See Alan Dershowitz statement) This is where being married and very happy precludes guilty behavior. Child



molesters will sometimes say, "I am a happily married man!" rather than "I didn't molest..." It is a tangent; not a denial. Q. Why not simply address the allegation?

EM: *You said you weren't very good friends but would you describe him as a good friend - did you trust him?*

Prince Andrew Interview A somewhat clever question given the context of needing to conceal illicit sexual activity.

Andrew: *Uh, yes, I think I probably did, but a-again, um, I mean -..*

Here he goes to motive---he did not go into a friendship (he used present tense language; not past tense) looking for the "wrong thing"-- that is, motive. His lack of commitment (present tense, "don't") is used to address motive, is followed by the expectation of ingratiation ("...if you understand what I mean") to make this interview friendly to him.

Personality Trait In the psycho-linguistic profile, we have been given two brief examples that suggest the need to explore the personality trait of not taking personal responsibility, but rather a willingness to blame others.

Although his earlier use of "we" could apply to the female that introduced him, he went immediately to Epstein.

We now listen for the additional information outside the boundary of the question, "*did you trust him*" as vital, as it is offered of his own accord. *I'm uh, I'm an engaging person. I want to be able to engage, I want to find out, I want to learn.*

He was curious. This is in context of Jeffrey Epstein and the allegation. *Um, and so, uh you have to remember that I was transitioning out of the Navy at the time um, and the transition, uh, I wanted to find out more*



about what was going on because in the Navy um, it's a pretty isolated business,

He was lonely. This is something "you", the interviewer (intended recipient) and the television audience (unintended recipient) "have to" remember. This is an example of emotional manipulation as he seeks to create sympathy from his audience.

Note that often the "unintended recipient" in analysis is the most important. *because you're out at sea the whole time, um, and I was going to become the Special Representative for International Trade and Investment, so I wanted to know more about what was going on in the international business world, and so that was another reason for going there, and the opportunities that I had to go to Wall Street and other places to learn, uh, whilst I was there, were - were absolutely vital. Besides being curious and isolated, becoming friends with Jeffrey Epstein was not his fault. He was going to become the "Special Representative for International Trade and Investment"--an important title, which explains why he wanted to "know more" about "what was going on" --- it is not his fault. This is a personality type where one may have grown up with very few consequences.*

EM: *He was your guest as well. In 2000 Epstein was a guest at Windsor Castle, and at Sandringham, he was brought right into the heart*

Andrew: *Yes, but –*

EM: - of the royal family at your invitation. The interviewer puts the burden of responsibility upon the subject with "at your invitation..."

Andrew: *but, uh - certainly at my invitation, not at the royal family's invitation, but remember that it was his girlfriend that was the key*



element in this. He was the, as it were, plus one, to some extent, in in in that aspect.

The word "but" is used to refute or to compare---here, to the statement that he, himself, did the invitation. The subject puts the weight of information off of himself and off of Epstein and on to the "girlfriend." Further affirmation of one who is inclined to blame others.

EM: *Am I right in thinking you threw a birthday party um, for Epstein's girlfriend, Ghislaine Maxwell, at Sandringham?*

Andrew: *No- it was a shooting weekend.*

EM: *A shooting weekend?*

Andrew: *Just a straightforward - straightforward shooting weekend.*

EM: But during these times that he was a guest at Windsor Castle, at Sandringham, uh, the shooting weekend

Andrew: *Yep, yeah, yeah*

EM: *- we now know that he was, and had been, procuring young girls for sex trafficking*

She now brings him closer to the allegation. He might have enjoyed debating the difference between a birthday party and a "straightforward shooting weekend." She wisely moved on from this tangent.

Andrew: *We now know that.*

"We"--- we cannot conclude that this, at this point, is psychological hiding in a crowd because it reflects the wording used by the interviewer. She used "we" and "now"--- unwise choices. At the time there was no indication to me, or anybody else that that was what he was doing - and certainly when I saw him, either in the United States when I, when I saw



him in the United States or when I was staying in his houses in the United States, there was no indication - indication. And if there was, absolutely no you have to remember that at the time uh, I was patron of the NSPCC's Fullstop campaign, so I was close up with what was going on in those, uh um - time about getting rid of abuse to children, so I knew what was - what the, what the things were to look for, but I never saw them.

a. "there was no indication to me" --he should have stopped there, but he has a need to persuade. He continued "or anybody else"--- which allows us to ask, "How would you know what "anybody else" perceived?"

b. "when I saw him in the United States" speaks to the element of location and is repeated.

c. "absolutely" in its follow up denial, is sensitive, yet this may be dismissed as appropriate given the greater context.

d. "And if there was" allows for the possibility - He is deceptive about knowledge of Jeffrey Epstein's "procuring young girls for sex trafficking" here.

Prince Andrew Interview He goes further, however, in his moralising, as one who was active in getting "rid of abuse to children." This is a very strong indicator of guilt. This is the need to portray oneself as a hero, when faced with an allegation of being the villain, rather than issue a denial. This point is alarming. It is consistent with child molestation.

EM: *So you would have made that connection because you stayed with him, were a visitor, a guest on many occasions at his homes, and as suspicious*

Andrew: *Nothing.*



EM: *During that whole time?*

Andrew: *Nothing.*

Nothing struck you The series of "yes or no" questions reduces the stress of the subject choosing his own words.

EM: *Just for the record, you've been on his private plane.*

Andrew: *Yes*

EM: *You've been to stay on his private island.*

Andrew: *Yes*

EM: *You've stayed at his home in Palm Beach,*

Andrew: *Yes*

EM: *You've visited Ghislaine Maxwell's house in Belgravia in London.*

Andrew: *Yes*

EM: *So, in 2006, in May, an arrest warrant was issued for Epstein for sexual assault of a minor,*

Andrew: *Yes*

EM: *In July he was invited to Windsor Castle, to your daughter, Princess Beatrice's, eighteenth birthday. Why would you do that?*

Andrew: *Because I was asking Ghislaine. But even so at the time, I don't think - I um, certainly I wasn't aware, when the invitation was issued, of what was going on in the United States, and I wasn't aware until the media picked up on it, because he never said anything about it.*

EM: *He never discussed with you*

Andrew: *___ Never discussed it.*



No pronoun note also that this was a specific time. note that "never" is to expand time, rather than focus in on a specific time. it is very likely that investigators could learn that he and Epstein spoke more frequently during this time period than he would wish to admit.

EM: *the fact that an arrest warrant had been issued?*

Andrew: *No.*

EM: *So he came to that party knowing police were investigating him?*

Andrew: *Well, I'm not quite sure whether - was it police? - I don't know, you see - this is the problem. I don't know. But I'm afraid you see, this is the problem, that an awful lot of this was going on in the United States and I wasn't a party to it and I knew nothing about it. The problem is not sexual abuse and trafficking but with his own knowledge. Another "problem" is social media.*

EM: *In 2008 he was convicted*

Andrew: *Yes*

EM: *of soliciting and procuring a minor for prostitution. He was jailed.*

Andrew: *Yes.*

EM: *This was your friend.*

Andrew: *Yeah.*

EM: *How did you feel about it?*

Andrew: *Well, I ceased contact with him after uh I was aware that he was um under investigation. And that was later on in in 2006 - and I wasn't in touch with him again until 2010 - so um, I just - just - it was one of those things that somebody's going through that sort of thing, well, I'm terribly sorry I can't be associated*



EM: *So no contact. When he was serving time*

Andrew: *No.*

EM: *- there was no call, no letter –*

Andrew: *No.*

EM: *-nothing there*

Andrew: *No.*

EM: *He was released in July. Within months, by December of 2010, you went to stay with him at his New York mansion. Why?*

Why were you staying with a convicted sex offender?

Andrew: *Right. I have always - um ever since this has happened, and since it's become public knowledge that I was there, I've questioned myself as to why did I go, and what was I doing, and was it the right thing to do. I went there with the sole purpose of saying to him that because he had been convicted it was n- it was inappropriate for us to be seen together.*

He gives indication of guilt and then, again, shifts responsibility to others: And I had a number of people counsel me in both directions - either to go and see him, or not to go and see him. And I took the judgement call that because this was um, serious, um, and chicken's way of doing it. I felt that doing it over the telephone was the Besides blaming others and using language warranted advanced analysis and exploration, he portrays himself as being brave for going to Epstein's mansion. This portrayal is another indicator of guilt. Keep in mind that the pronoun "we" indicates unity. This is why a rape victim will change to "he and I" from "we" once the assault has taken place. Here, he instinctively tells us that he is unified with Jeffrey Epstein. I had to go and see him and talk to him. Um, and I went to see him, uh, and I was doing



a number of other things in New York at the time, um, and we had an opportunity to go for a walk in the park, and that was the conversation um, coincidentally, that was photographed, which was when I said to him, I said, look, because of what has happened, I don't think it is appropriate that we should remain in contact. And by mutual agreement, during that walk in the park, we decided that we would part company, and I left, I think it was the next day, and th- to this day, I never had any contact with him from that day forward. He is lying here. He is revealing two major points:

1. Just how unified he was with his friend
2. He is withholding vital information at this time ("I left") about he and Epstein's discussion.

EM: *What did he say when you told him that you were breaking up the friendship? She asked what was said; not what was not said:*

Andrew: He was what I would describe as understanding. Um, He didn't go into any great depth, um in the conversation about what I was doing - what he was doing, um, except to say that, that uh, uh, he had accepted whatever it was, a plea bargain, he'd served his time um and uh, he was carrying on with his life, if you see what I mean, and I said yes, but afraid that that - that, that's as maybe, um, but with all the attendant I'm scrutiny on me, then I don't think it is a wise thing to do.

No sympathy for the victims.

EM: *Who advised you, then, that it was a good idea to go and break up the friendship? Did that come from the Palace*

Andrew: *No.*



EM: *Was Her Majesty the Queen involved?*

Andrew: - no, no, no, no, no.

EM: *That was December of 2010*

Andrew: *Yep.*

EM: *he threw a party to celebrate his release, and you were invited as the guest of honour.*

Andrew: No, I didn't go.

This is a strong response----rare in the interview. He immediately changes, however, to reclassifying it as something else. This appears to come natural to him: Oh, in two thousand and ten, there wasn't - there certainly wasn't a party to celebrate his release in December, because it was a small dinner party. There were only eight or ten of us, I think, at the dinner. If there was a party, then I know nothing about that.

EM: You were invited to that dinner as a guest of honour.

Andrew: *Well I was there, so there was a dinner. I don't think it was quite as you might put it. Okay I was there for, I was there for a dinner, yeah.*

He cannot state that he went to celebrate his friend's release, but that he went there for dinner.

EM: *I was just trying to work this out, because you said you went to break up the relationship and you stayed at that New York mansion several days. I'm wondering how long?*

Andrew: *But I was doing a number of other things while I was there*

EM: *But you were staying at the house of a convicted sex offender.*

Andrew: *It was a convenient place to stay*



His own phrasing is revealing: *"I've gone through this issue in my mind so many times... with hindsight it was definitely the wrong thing to do, but at the time I felt it was the honourable and right thing to do... I admit fully that my judgement was probably coloured by my tendency to be the way it is."*

This is not genuine accountability. It is a performance of responsibility rather than the act itself. Stress is invoked, "honour" is invoked, but both function as self-protective narratives. The "good guy" principle appears again — he was *too honourable*, supposedly — a classic form of projected guilt. The possibility of substance abuse should not be dismissed, as it often accompanies this pattern of distorted self-presentation.

EM: *During that time, those few days, witnesses say they saw many young girls coming and going at the time, and there is video footage of Epstein accompanied by young girls. And you were there, staying in his house, catching up with friends.*

Andrew: *I never, I mean if there were, then um I wasn't a party to any of that. I never saw them. I mean, you have to, you have to understand that, that that that, his house, I've described it more as a, as, as a, almost as a railway station, if you know what I mean, in the sense that there were people coming in and out of that house all the time. Um, what they were doing, and why they were there I had nothing to do with so I - I'm afraid I can't make any comment on that because I - I really don't know*

EM: *Another guest was John Brockman, the literary agent,*

Andrew: *Really?*

EM: *he described seeing you there, getting a foot massage from a young Russian woman. Did that happen?*



Andrew: *No*

EM: *You're absolutely sure, or you can't remember,*

Andrew: *Yeah I'm absolutely sure.*

EM: *So John Brockman's statement is false?*

We now see closed questioning which is something that clearly has been agreed. Asking an open question would be the way forward not giving him a chance to escape.

Andrew: *I wouldn't - I wouldn't. I don't know Mr Brockman, so I don't know what he's talking about*

Deception

EM: *But that definitely wasn't you getting a foot massage from a Russian girl in Jeffrey Epstein's house?*

Andrew: *No*

EM: *It might seem a funny way to break off a friendship, a four day house party of sorts, with a dinner. It's an odd way to break up*

Andrew: *It's a difficult way of putting - that's a very um, stark way of putting it yes, you're absolutely right, um, but actually, the -the the truth of it is that I actually only saw him for about what? the part that the dinner party, the walk in the park, and probably passing - um, in the passage.*

EM: *So let's go to that Central Park walk*

Andrew: *Yeah*

EM: *which*

Andrew: *Yeah*



EM: - was snapped. Friends of yours suggest that Epstein wanted that photo taken, perhaps he'd even set it up. Do you worry that you were being played?

The topic of being set up ---this is a form of betrayal of a friendship. If allegations of sexual abuse and trafficking of teenaged girls was not enough to eject the pronoun "we" from his language, would personal betrayal? Introduced to the subject, we look at the remaining interview transcript for a change in linguistic disposition ---where he goes negative about Jeffrey Epstein.

Andrew: Again, um, new information is coming out, um, since his suicide, um, has made us reappraise that - uh, walk in the park. We can't find any evidence, uh - or my staff, and my people, and I can't find any evidence to suggest that that was what he was doing. I mean, you can look at it in so very many ways but the fact of the matter is that somebody, very cleverly, took that photograph. It wasn't, um, as far as I remember, nor do my security people remember anybody being present or close. Um, because there were enough security around - I mean there are even photographs of the security people around in the photograph, So, I. I mean, he could've, he could've done - but

He does not turn negative towards Epstein.

EM: Yeah. I guess what I'm asking is do you feel that you were part of Epstein's public rehabilitation?

Andrew: Oh - no, funny enough I don't. No. I mean - if, if, if he was - if he was doing - if that photograph was taken for that, with that purpose in mind, then it doesn't - it doesn't equate to what actually happened.



EM: *So, why wouldn't you announce this break up when you got back? Why wouldn't you publicly explain what you'd done? Did you worry that he had something that could compromise you?*

Andrew: *No. No*

EM: *Do you regret that trip?*

Andrew: *Yes.*

EM: *Do you regret the whole friendship with Epstein?*

Andrew: *Um, uh - now, still not, for- and the reason being is that the people that I met, um, and the opportunities that I was given to learn, um - either by him or because of him, were actually very useful. He himself, um, not as it were, as close as you might think, we're not - we weren't that close, so therefore, I mean - yes, I would go and stay in his house, but that was because of his girlfriend, not because of him.*

The pronoun "we" is used to unite the subject to Epstein.

EM: *Was that visit, December of 2010, the only time you saw him after he was convicted?*

Andrew: *Yes,*

EM: *Did you see him or speak to him again?*

Andrew: *No, no.*

EM: *And stay with him -*

stay in the house of a convicted sex offender.

Andrew: *I could easily have gone and stayed somewhere else, but sheer convenience of, of, of being able to get a hold of the man is, was - I mean he was in and out all over the place, so getting him in one place for a,a,a*



period of time - to actually have a long enough conversation to say look, these are the reasons why I'm not going to - and that happened on the walk.

EM: *July of this year, Epstein was arrested on charges of sex trafficking and abusing dozens of underage girls. One of Epstein's accusers, Virginia Roberts*

Andrew: *Yes*

EM: *has made allegations against you. She says she met you in two thousand and one; she says she dined with you, danced with you at Tramp nightclub in London, she went on to have sex with you in a house in Belgravia, belonging to Ghislaine Maxwell, your friend. Your response?*

Andrew: *I have no recollection of ever meeting this lady, none whatsoever.*

He was not accused of ever "meeting" her, but having sex with her. A middle aged man is accused of dancing and having sex with a teenaged girl--this is a "hormonally consequential event" in analysis. He is lying. He is not able to issue a reliable denial such as "I did not have sex with Virginia Roberts" which could have been followed by "I've never met her, either"-- If Prince Andrew is incapable or unwilling to say it, we shall not say it for him.

EM: *You don't remember meeting her.*

Andrew: *No.*

EM: *She says she met you in 2001, she dined with you, she danced with you, you bought her drinks, you were in Tramp nightclub in London, and she went on to have sex with you in a house in Belgravia, belonging to Ghislaine Maxwell*



Andrew: *Didn't happen*

Here, the subject is removed from his answer. "Didn't happen" to whom? by whom? There is no human in this answer to the most pressing allegation made.

EM: *Do you remember her?*

Andrew: *No. I-I-I- I have no recollection of ever meeting her, um, I'm almost, in fact, I'm convinced, uh, that I was never in Tramps with her. There are a number of things that are wrong with that story, one of which is that, is that I don't know where the bar is in uh Tramps. Um, I don't drink, um, I don't think I've ever bought a drink in Tramps whenever I was there.*

The stuttering "I" now indicates anxiety at this question.

EM: *Do you remember dancing at Tramp?*

Andrew: *No. That couldn't have happened because the date that is being suggested I was at home with the children.*

EM: *You know that you were at home with the children?*

Andrew: *uhum.*

EM: *Was it a memorable night?*

Andrew: *On that particular day that uh we now understand is the date, which is the tenth of March, I was at home - I was with the children, and I'd taken Beatrice to, uh, a Pizza Express in Woking, for a party, I suppose about four or five in the afternoon, um, and then because the Duchess was away, we have a simple rule in the family, that when one's away, the other one is there. I was on terminal leave at the time, um, from the Royal Navy, so therefore, I was at home.*



EM: *Why would you remember that so specifically, why would you remember a Pizza Express birthday and being at home?*

Andrew: *Because going to Pizza Express in Woking is an unusual thing for me to do. A very unusual thing for me to do. I've never been, I've only been to Woking a couple of times, um, and I remember it weirdly distinctly. As soon as somebody reminded me of it, I went, oh, yes, I remember that.*

Having sex with a teenaged girl is not "an unusual thing" for the subject. He has more victims.

EM: *So Andrew: But I have no recollection of ever meeting, or being in the company, or the presence So, you're absolutely sure that you were at home on the tenth of March.*

Andrew: *Yeah.*

EM: *She was very specific about that night.*

Andrew: *Uhum*

EM: *She described dancing with you*

Andrew: *No. "I didn't dance with her, nor have sex with her. I never even met her"*

EM: *And you profusely sweating, and that she went on to have - baths, possibly*

This is a sensory detail; often from experiential language. Even if a specific date is off, the detail warrants exploration. The subject portrays himself as a victim in his question to show why this "never happened"--- rather than deny it. Direct lies cause more internal stress. This is why we see the unreliable denials as well as tangents and needless explanations (along with portrayals of being "the good guy")



Andrew: *There's a slight problem with - with - with - with the sweating - um, because I - I - I have a peculiar medical condition which is that I don't sweat, um, or I didn't sweat at the time, and that was - oh, was she? - yes, I didn't sweat at the time because I um, had suffered what I would describe as an overdose of Adrenalin in the Falklands War, when I was shot at, uh, and I simply - it-it was - it was almost impossible for me to sweat. And it's only because I have done a number of things in the recent past that I'm starting to be able to - do that again. So, I'm afraid to say that there's a medical condition that says I didn't do it,*

So therefore.. Note the lack of self awareness in the absurdity of explanation as to "why" he couldn't "sweat"—

EM: *Is it possible that you met Virginia Roberts, dined with her, danced with her in Tramp, had sex with her, on another date?*

Andrew: *No*

EM: *Do you remember meeting her at all?*

Andrew: *No*

EM: *Do you know you didn't meet her, or do you just not remember?*

Andrew: *No I have - I don't know of meeting her if I have met. But no, I have no recollection*

EM: *She was very specific - she described a dance that you had together in Tramp, she described meeting you, she was a seventeen year old girl meeting a senior member of the royal family.*

Andrew: *Never happened*

Psychological ejection of self. This is to show a lack of ownership. It is easy to say, "I didn't have sex with Virginia Roberts"--- it is the



psychological wall of truth to stand safely behind. This would mean there is no reason for buttressing anything with explanations or qualifications.

EM: *She provided a photo of the two of you together*

Andrew: *Yes*

Confronted, he will not go further.

EM: *Your arm was around her waist*

Andrew: *Yes*

Confronted again, he will not go further. She adds in detail.

EM: *You've seen the photo*

Andrew: *I've seen the photograph*

Parroting reduces stress. She is forced to ask:

EM: *How do you explain that?*

Andrew: *I can't. Because I don't - again I have absolutely no memory of that photograph ever being taken*

Listen to him. Of what does he have no memory (not "recollection" here)? He has no memory of meeting her? putting his arm around her? No. He has no memory of the photograph being taken.

EM: *Do you recognise yourself in the photo*

Andrew: *Oh, yeah - pretty difficult not to recognise yourself.*

He is a manipulator.

EM: *Your friend suggested that the photo is fake.*

She should not have offered this, but allowed him to, even if it means uncomfortable silence before the camera. Since he is so image driven, he



likely would not have let the silence go for long. In defence of the interviewer, this is TV, not an investigatory interview. In the latter, silence is a powerful tool.

Andrew: *I think it's, from the investigations that we've done, you can't prove whether or not that photograph is uh faked or not, because it is a photograph of a photograph of a photograph, so it's very difficult to be able to - to um, prove it, but I-I don't remember that photograph ever being taken*

He is willing to talk about the photograph being taken, but not about meeting or being with her.

EM: *But It's possible that it was you with your arm around*

Andrew: *That's me - but whether that's my hand, or whether that's the position - I- I - but I don't - I have simply no recollection of the photograph ever being taken.*

The middle aged man put his arm around a teenaged girl.

EM: *The world has now seen the photo that Virginia Roberts provided, taken by Epstein, we understand, in Ghislain Maxwell's house.*

Andrew: *Here's the problem. I've never seen Epstein with a camera in my life*

Yet another addressing of "the problem"--- he employs tangent deception rather than address the evidence.

EM: *I think it was Virginia Roberts camera, she said a little Kodak one that she lent to Epstein, took a photo, and your arm is round her waist.*

Andrew: *I don't remember - I don't remember uh that photograph ever being taken. I don't remember going upstairs in the house, because that*



photograph is taken upstairs. Um, and I'm not entirely convinced - that is, that is what I would describe as me in that picture, but I can't - we can't be certain as to whether or not that's my hand.

I can't be certain that's my hand on, on, on her - whatever it is - left side he is lying.

EM: *Because you think*

Andrew: *I have no recollection of that photograph ever being taken Rather than deny putting his arm around her.*

EM: *So why would somebody have put in another hand? You think it is you next to her in the picture*

Andrew: *Oh, it's definitely me.. that's a picture of me. It's not a picture of - I don't believe it's a picture of me in London, because when I go out in London I wear a suit and a tie. That's what I would describe as, those are my travelling clothes - if I'm going to go overseas. I've got plenty of photographs of me dressed in - in - in those sorts of - that sort of kit, but not there.*

EM: *To clarify, you think that photo has been faked.*

Andrew: *Nobody can prove whether or not that photograph has been doctored, but I don't recollect that photograph ever being taken.*

EM: *And you don't recollect having your hand round her waist?*

Andrew: *No.*

EM: *In Ghislaine Maxwell's house.*

Andrew: *No, no.*

EM: *On any occasion, even if it was a different date*



Andrew: *I'm terribly sorry, believe him. but if I, as a member of the royal family, and I have a photograph taken and I take very, very few photographs- I am not one to, um, as it were, hug, and um, public displays of affection are not something that, that I do. So, I - I that's the best explanation I can give you, and I'm afraid to say that I don't believe that photograph was taken in the way that has been suggested.*

EM: *Why would people not believe that you were there?*

Andrew: *I'm sorry, why would?*

EM: *I'm just trying to understand- there's a photo inside Ghislaine Maxwells house, herself is in the background, why would people not believe that you were there with her that night?*

Andrew: *Um, they might well wish to believe it, but, but there's a - the photograph is taken upstairs and I don't think I ever went Ghislaine's house.*

EM: *Are you sure of that? upstairs, um, in*

Andrew: *Yeah, because - because the dining room and everything was on the, was on the ground floor. It was, it was as you came in the hall. So I don't remember ever going up there. I'm at a loss to explain this particular photograph um, if the, if the original was ever produced, then perhaps we might be able to solve it, but I can't*

EM: *You can say categorically that you don't recall meeting Virginia Roberts, dining with her*

Interviewers ought not say what the subject will not say

Andrew: *Yep*

EM: *Dancing with her at Tramp*



Andrew: *Yep*

EM: *Or going on to have sex with her*

Andrew: *Yes*

EM: *in a bedroom at a house in Belgravia*

Andrew: *I can, I can absolutely categorically tell you it never happened.*

EM: *Do you recall any kind of sexual contact with Virginia Roberts?*

Very weak series of questions. She is reducing his stress level

Andrew: *None*

EM: *Then or at any other time?*

Andrew: *None whatsoever*

EM: *Because she said in a legal deposition, a legal court document in 2015, she had sex with you three times.*

Andrew: *No*

EM: *She is not confused about this - she said the first was in London when she was trafficked to you, the second was at Epstein's mansion in New York,*

Andrew: *That is a date in April, I believe, Is that correct?*

Psychological Wall of Truth: having not had sexual contact with the accuser, dating should be of little, if any, importance. It would not matter had he not have guilt. This is to slow the pace of information down or to 'run out the clock' of the interview.

EM: *She said it was a month or so later.*



Andrew: *Yeah. Well I think that the date we have for that uh, uh - uh, shows that I was in Boston, uh, or I was in New York um the previous day and I was at a dinner for the Outward Bound Trust, uh, in New York, and then I flew up to Boston the following day, and then on the day that she says this occurred, she - they'd already left in, uh, to go to the island, before I got back from Boston, so it, it - I don't think that could have happened at all*

EM: *There was a witness there, Yohanna Stalberg, who said that you did visit the house in that month.*

Andrew: *I probably did. I don't think - one of the weirder things - I was staying with the, uh, because of what I was doing, I was staying with the consul general, which is further down the street, on, on, on Fifth, so I wasn't staying there- It may have visited but I, but, but no, definitely didn't no activity no. - no,*

Investigators should explore this period of time for sexual activity that the subject would consider "weird" ---always allowing the subject to define all activity.

EM: *Because in a legal deposition, 2015, she said she had sex with you three times. once in a London house , she was trafficked to you, in Maxwell's house,*

Here he should deny, not affirm, her words of accusation:

Andrew: *Yes*

EM: *Once in New York, a month or so later at Epstein's mansion, and once on his private island in a group of seven or eight other girls.*

Andrew *No*

EM: *No to all of it?*



Andrew: *All of it.. absolutely no to all of it.*

EM: *Why would she be saying those things?*

Andrew: *We wonder exactly the same but I have no idea., absolutely no idea*

EM: *She made these claims in a US deposition*

Andrew: *Uhum.*

EM: *Are you saying you don't believe her, she's lying?*

Yes. Unequivocally "yes" is the only appropriate answer to the allegation of having sex with a teenaged girl he had never met. There is no unity, nor "peace" between a false allegation of sexual exploitation and an innocent accused. Instead, he avoids condemning her-- this is sometimes seen in the fear of bringing further resolve to a case to prove his guilt. It is very simple--- "she is lying"—

Andrew: *That's a very difficult thing to um, answer because I'm not in a position to know um, uh, what, what she's trying to um, achieve, but I can tell you categorically,*

Denial of "I didn't have sex with her"? I don't remember meeting her, at all, note the progression and the emphasis I do not remember the photograph being taken and I've said consistently and um, frequently, that we never had any sort of sexual contact whatever. First, this is an unreliable denial ("never") Secondly, it is an admission of knowing her by pronoun: "we"-- he unites himself with a lying, false accuser by the pronoun "we" here. Thirdly, he does not deny ever having sex with her--- listen to him---he self references early things he has "said consistently"-- context: in a live and stressful interview. This indicates he is working from script; not experiential memory.



EM: *She spoke about you, outside the court in August this year. She said, "He knows exactly what he's done and I hope he comes clean about it."*

Andrew: *And the answer is nothing*

EM: *So if Virginia Roberts is watching this interview, what is your message to her?*

Andrew: *I don't have a message for her, because I have to have a thick skin. If somebody is going to make those sorts of allegations then I just have to have a thick skin and get on with it - but they never happened.*

EM: *For the record, is there any way you could have had sex with that young woman, or any young woman trafficked by Jeffrey Epstein, in any of his residences?*

It was sensible to shift the wording to "young woman," but she should have stopped there and allowed him to answer. Only after his unedited response should the questioning have moved toward Epstein and trafficking. By giving him extra framing, she inadvertently offered an escape route: he could reinterpret the situation as something involving an assistant rather than Epstein himself, reducing the psychological pressure of the question.

From an analytical-interviewing standpoint, this is a missed opportunity. The fewer words we use, the more the subject is forced into free editing — revealing their own priorities, assumptions, and internal logic.

Over-explaining or padding a question dilutes that effect and hands the subject ready-made narratives to hide behind.

Andrew: *No. Um. And, and and without putting too fine a point on it, if you're a man, it is a positive act, to have sex with somebody. You have to take some sort of positive action, and so therefore if you try to forget -it's very difficult to try and forget positive action, and I do not remember*



anything. I can't, I've wracked my brain - thinking - oh, when the first allegation, when the allegations came out originally I went, well, that's a bit strange, I don't

EM: *Epstein's housekeeper, also in a Florida court legal deposition, said that you visited the Palm Beach residence, around four times a year you got a daily massage.*

Andrew: *Four times a year?*

EM: *That was what he said, in a Florida court legal deposition.*

Andrew: *No*

EM: *i'm just wondering, when you look back now, is there a chance that those massages might have been the services of someone who was being sexually exploited or trafficked by Epstein?*

Andrew: *N-no. I don't think - I mean I - no, absolutely not. definitely not, definitely not, and I definitely did not visit, uh, his Palm Beach house three or four times a year.*

EM: *How many times would you say you visited?*

Andrew: *Ah, in total, probably four times. In total throughout the- the time that I knew him..*

It was at likely other locations that trigger guilt from him. He slowly reveals himself as a manipulative and serial exploiter; with or without Epstein.

EM: *So that's where you'd find him.*

Andrew: *- um, but it was usually because I was going, I was going through and on somewhere else, so it was a day, it was, it was, that was it.*



EM: *You said in your statement, from the Palace, "at no time did I see, witness or suspect any suspicious behaviour." Virginia Roberts' legal team says you could not spend time around Epstein and not know what was going on –*

you could not spend time around Epstein and not know what was going on.

Andrew: *If you are, um, somebody uh, like me then people behave in a subtly different way. he only spots "abuse of children" but not someone who had a life dedicated to sexual exploitation of teenaged girls? Um, you wouldn't - first of all I'm not looking for it, that's the thing, you see if you are looking for it, then you might have suspected now, with the benefit of a huge amount of hindsight, and a huge amount of analysis, you look back and you can think, well, was that really the way it was, or was it, was I looking at it in the wrong way, but you don't go into these places, you don't go to stay with people looking for - for that.*

EM: *You could not spend time around him - that's what they said. You could not spend time around him and not know.*

Andrew: *Look, the other aspect of this is that, is that um, I live in uh, in an institution, at Buckingham Palace, which has members of staff walking around all the time. And I don't wish to appear grand, but there were a lot of people who were walking around Jeffrey Epstein's house. As far as I was aware they were staff, they were people that were working for him, doing things, I, as it were, I interacted with them in saying good morning, good afternoon, but I didn't, if you see what I mean, interact with them in a way that was, "What are you doing here? Why are you here? What's going on?"*

EM: *But you'd notice if there were hundreds of underage girls in Buckingham Palace, wouldn't you?*



Andrew: *Oh God - sorry, you'd notice if there were hundreds of underage girls in Jeffrey's house, it wasn't there - not when I was there. Now he may have changed his behaviour patterns in order for uh, that not to be obvious to me. So - I don't - you're asking me to speculate on things that I just don't know about.*

EM: *You seem utterly convinced you're telling the truth. Would you be willing to testify or give a statement under oath if you were asked?*

Andrew: *Well I'm like everybody else and I - I'm, I - and I would have to take uh, all the legal advice, um, that there was before I was to - to do that sort of thing, but if push came to shove and the legal advice was to do so, then I would be duty bound to do so.*

His claim to normality ("I'm like everybody else") indicates he is unlike everyone else. Note the stress this causes.

EM: *Because you've said there are many unanswered questions, everyone effected wants closure, you would help to provide that closure?*

Andrew: *If there was, if in the right circumstances, yes, I would because I think there's just as much um, closure for me as there is for everybody else. Um, and undoubtedly - some very strange and unpleasant activities have been going on. I'm afraid to say that I'm not the person that can shed light on it,*

EM: *Virginia Roberts' lawyers, legal team, say that they've asked for a legal statement from you, there is an active FBI investigation now - would you be willing to provide that?*

Andrew: *Again, I'm, I'm, I'm bound by what my legal legal advisors, tell me.*

EM: *Epstein was found dead.*



Andrew: *Yep.*

EM: *In prison*

Andrew: *Yes*

EM: *in August of this year.*

Andrew: *Yep. advice is - um, um, and*

EM: *What was your response on hearing that he'd died?*

Andrew: *Shock.*

EM: *Some people think that he didn't take his own life.*

Andrew: *There again I'm not one to be able to answer that question. Um, I believe that centres around something to do with a bone in his neck. Um, so whether or not if you commit suicide that bone breaks, or something. Um, but I'm afraid to say I'm not an expert. Andrew: *In the same way that I have questions to answer, in the sense of what was I doing, um, and as I say, that - that I was there to - to my mind, honourable and say to him, look you've been convicted, it would be incompatible for me to be seen with you. be Unfortunately somebody was Interview standing around with a camera at the time and got a photograph of us - uh, it's one of the very few photographs there are of us - but that was - that was the case. Um, if there are questions that*



Ghislaine has to answer, that's her um, problem, I'm afraid, I'm not in a position to be able to comment one way or the other.

EM: *When was your last contact with her?*

Andrew: *Uh, it was earlier this year, funnily enough, in the summer. In the spring - summer.*

EM: *About what?*

Andrew: *She was here, um doing some rally.*

EM: *So, even though he had by then been arrested, and was facing charges of sex trafficking,.*

Andrew: *No - no, no, no, no, this was early spring - I think. It was long because, when was he arrested?*

EM: *July.*

Andrew: *No, it was before July.*

EM: *And that was the last time.*

Andrew: *Yeah, yeah.*

EM: *Did you discuss Epstein?*

Andrew *No. Actually, funny enough, no - not at all. There wasn't anything to discuss about him because he wasn't in the news. He wasn't - you know, just - we'd moved on.*

EM: *I want to talk about moving on.*

Andrew: *oh, yeah, yeah, alright, okay.*

EM: *Epstein is dead.*

Andrew: *Yes.*



EM: *The women are now being heard.*

Andrew: *Quite rightly*

EM: *How do you move on from this?*

Andrew: *Uh, well, that's an interesting way of putting it. Um, I'm, I'm carrying on with what I do. um I have a number of things I have been doing since two thousand and eleven. Um, they're pretty well organised, pretty successful, and so I'm, I'm carrying on, trying to improve those things that I'm already doing..*

EM: *Has the episode been damaging to the royal family, to Her Majesty the Queen?*

Andrew: *I don't believe it's been damaging to, uh, the Queen, at all.*

Victims' accounts of abuse

ARINA, 13 years of age.

A refugee from Ukraine, fled her homeland in April 2022. She had some health challenges and was raised in the children's home "Perlinka" located in the village of Voynovka in the Kirovograd region of Ukraine from the age of four. Following the announcement of the evacuation in spring 2022, Arina was relocated to the UK, where she was promptly placed under the care of Mermaids charity based in London.

According to a whistle-blower who had gone undercover, the young Ukrainian girl was forced to take nude pictures, and four months after her stay in the UK she was abducted by people linked to the British Royal



Family. In April 2024, we found out that the minor Arina had committed suicide.

A 15 year old female pupil boarding at the Aldenham School in Hertfordshire, came forward with the support of her parents and told us that she, along with others, became victims of sexual abuse by teachers and trustees of the school, as well as by high-ranking guests. These included King Charles III, Bishop Michael Beazley of Hertford and Prince Edward.

The school library was used for this purpose, where minors were forced to watch a student being beaten and sexually assaulted. The audience included high-ranking politicians and public figures who watched from a separate box. After such “performances”, the invited adult spectators could choose “one to three children” for themselves, after which they could have a private moment with them in an isolated area she is currently living abroad after she confessed to her father and mother. His daughter is currently receiving therapy but the family have been threatened.

2 - Understanding comprehensive sexuality education

This section provides a new definition and description of comprehensive sexuality education and presents key considerations for understanding the evolving field of CSE.

2.1 What is comprehensive sexuality education (CSE)?

Comprehensive sexuality education (CSE) is a curriculum-based process of teaching and learning about the cognitive, emotional, physical and social aspects of sexuality. It aims to equip children and young people with knowledge, skills, attitudes and values that will empower them to: realize their health, well-being and dignity; develop respectful and sexual relationships; consider how their choices affect their own well-being and that of others; and, understand and ensure the protection of their rights throughout their lives.

CSE is education delivered in formal and non-formal settings that is:

- It supports learners' empowerment by improving their analytical, communication and other life skills for health and well-being in relation to sexuality, human rights, a healthy

...ial aspects of sexuality. It aims to equip children and young people with knowledge, skills, attitudes and values that will empower them to: realize their health, well-being and dignity; develop respectful social and sexual relationships; consider

and development of learners. CSE addresses developmentally-relevant topics when it is most timely for their health and well-being. It accommodates developmental diversity; adapts content when cognitive and emotional development is delayed; and is presented when the internalization of SRH and relationship-related messages is most likely.

Curriculum based: CSE is included within a written curriculum that guides educators' efforts to support students' learning. The curriculum includes key teaching objectives, the development of learning objectives, the presentation of concepts, and the delivery of clear key messages in a structured way. It can be delivered in either in-school or out-of-school settings.

Comprehensive: CSE provides opportunities to acquire comprehensive, accurate, evidence-informed and age-appropriate information on sexuality. It addresses sexual and reproductive health issues, including, but not limited to: sexual and reproductive anatomy and physiology; puberty and menstruation; reproduction, modern contraception, pregnancy and childbirth; and STIs, including HIV and AIDS. CSE covers the full range of topics that are important for all learners to know, including those that may be challenging in some social and cultural contexts.

time, throughout their education, rather than a one-off lesson or intervention.

Based on a human rights approach: CSE builds on and promotes an understanding of universal human rights – including the rights of children and young people – and the rights of all persons to health, education, information equality and non-discrimination. Using a human rights-based approach within CSE also involves raising awareness among young people, encouraging them to recognize their own rights, acknowledge and respect the rights of others, and advocate for those whose rights are violated. Providing young people with equal access to CSE respects their right to the highest attainable standard of health, including safe, responsible and respectful sexual choices free of coercion and violence, as well as their right to access the information that young people need for effective self-care.

Based on gender equality: CSE addresses the different ways that gender norms can influence inequality, and how these inequalities can affect the overall health and well-being of children and young people, while also impacting efforts to prevent issues such as HIV, STIs, early and unintended pregnancies, and gender-based violence. CSE contributes to gender equality by building awareness of the centrality and diversity of gender in people's lives; examining gender norms shaped by cultural, social and biological differences and similarities; and by encouraging the creation of respectful and equitable relationships based on empathy and understanding. The integration of a gender perspective throughout CSE curricula is integral to the effectiveness of CSE programmes. To learn more on how to understand the concept of gender, see Section 9 - Glossary.

Culturally relevant and context appropriate: CSE fosters respect and responsibility within relationships, supporting learners as they examine, understand and challenge the ways in which cultural structures, norms and behaviours affect people's choices and relationships within a specific setting.

Transformative: CSE contributes to the formation of a fair and compassionate society by empowering individuals and communities, promoting critical thinking skills and strengthening young people's citizenship. It provides learners with opportunities to explore and nurture positive values and attitudes towards SRH, and to develop self-esteem and respect for human rights and gender equality. Additionally, CSE empowers young people to take responsibility for their own decisions and behaviours, and the ways in which they may affect others. It builds the skills and attitudes that enable young people to treat others with respect, acceptance, tolerance and empathy, regardless of their ethnicity, race, social, economic or immigration status, religion, disability, sexual orientation, gender identity or expression, or sex characteristics.

Able to develop life skills needed to support healthy choices: this includes the ability to reflect and make informed decisions, communicate and negotiate effectively and demonstrate assertiveness. These skills can help children and young people form respectful and healthy relationships with family members, peers, friends and romantic or sexual partners.

Box 1. Conceptual framework for sexuality in the context of CSE

The concept of sexuality is not a simple one to define. Numerous experts in the fields of public health and sexology have discussed basic concepts referring to sexuality and have put forward an agreed working definition and conceptual framework (Pan American Health Organization/World Health Organization, 2000; WHO, 2006a).

'Sexuality' may thus be understood as a core dimension of being human which includes: the understanding of, and relationship to, the human body; emotional attachment and love; sex; gender; gender identity; sexual orientation; sexual

These skills can help children and young people form respectful and healthy relationships with family members, peers, friends and romantic or sexual partners.

(Weeks, 2011).

- Sexuality is linked to power. The ultimate boundary of power is the possibility of controlling one's own body. CSE can address the relationship between sexuality, gender and power, and its political and social dimensions. This is particularly appropriate for older learners.
- The expectations that govern sexual behaviour differ widely across and within cultures. Certain behaviours are seen as acceptable and desirable, while others are considered unacceptable. This does not mean that these behaviours do not occur, or that they should be excluded from discussion within the context of sexuality education.
- Sexuality is present throughout life, manifesting in different ways and interacting with physical, emotional and cognitive maturation. Education is a major tool for promoting sexual well-being and preparing children and young people for healthy and responsible relationships at the different stages of their lives.

On page 71, educators are instructed to teach little kids from the age of 5 about kissing, hugging, touching and **sexual behaviors**. 9-year-old children are to be taught about masturbation, **sexual attraction and sexual stimulation**.

Learning objectives (5-8 years)

Key idea: People can show love for other people through touching and intimacy

Key idea: Children should understand what is and what is not appropriate touching

Learners will be able to:

(5-8 years)

Teach 5 year old kids about sex

- ▶ state that people show love and care for other people in different ways, including kissing, hugging, touching, and sometimes through sexual behaviours (knowledge).




The agenda to ensure that little children have sexual partners is being further developed by the World Health Organization. Their document, "Standards for Sexuality Education in Europe",² contains the following instructions for kindergartens and elementary schools:

✓ Children between 0 and 4 years must learn about masturbation and develop an interest in their own and others' bodies.

✓ Children between 4 and 6 years must learn about masturbation and be encouraged to express their sexual needs and wishes.

✓ Children between 6 and 9 years must learn about sexual intercourse, online pornography, having a secret love and self-stimulation.

✓ Children between 9 and 12 years should have their first sexual experience and learn to use online pornography.



Rutgers Global publisher of sex Education



This country serves as the base for a global publisher of "comprehensive sexuality education": the Rutgers Foundation. A staff member from Rutgers, **Ineke van der Vlugt**, contributed to the WHO's "Standards for Sexuality Education in Europe," highlighting the close collaboration between this foundation and the World Health Organization. Additionally, as mentioned earlier, Rutgers receives funding from Bill Gates, Planned Parenthood, and the UN, and operates in 27 countries.



In the spring of 2023, Rutgers kicked off a nationwide curriculum in The Netherlands called "Spring Fever." A poster was displayed in elementary schools across the country. I've translated it into English for our global audience and highlighted key points to convey the message of this school poster. Two boys are holding hands and saying, "Yes, we both want it." Meanwhile, two young girls are finding a "safe place" to engage in sexual activity.

The following is an example of an official school curriculum in The Netherlands, published by the School Curriculum Education (School Leerplan Onderwijs), the official publisher of all school curriculums. We can see that it is a direct implementation of the WHO "Standards for Sexuality Education", and UN "International Technical Guidance on Sexual Education":¹¹

- ✓ Toddlers in the **age group of 0-4** must learn about falling in love, intimacy and sexual feelings.
- ✓ Little kids from the **age of 5** should learn about sexual intercourse, online pornography and experiencing lust through touching their own body.
- ✓ From the **age of 7** they should learn different sexual techniques.

It's concerning to see that many schools are now introducing games for kids that require them to memorise the names of genitals just to earn points. This approach seems aimed at stripping away healthy feelings of natural shame and desensitising young children, making them more vulnerable to inappropriate sexual advances. Most of us find this pretty disturbing. Just think about the kind of effect this could have on young kids who are being exposed to this in their schools. These games are already popping up in European schools and are being pushed towards the UK and the USA as part of a broader program.



Part of the Rutgers / WHO / UN school program "Spring Fever" is handing out 3D clitorises to little girls to encourage them to start masturbating. This is of course defended with claims of how important it is for girls to know their own body.

It depends on each individual school as to what degree they implement the instructions of the UN and WHO, and naturally certain schools will be worse than others. But it is mandatory for every public school in the world.



On June 22, 1979, Rutgers signed a petition, along with criminally convicted child molester Brongersma, for the legalizing of sex with children.

The current chairman of the Supervisory Board of Rutgers is Andrée van Es, former politician of the Green Left and PSP, a party that also lobbied for the legalisation of paedophilia.

Former director of Rutgers, Pieter Wijnsma, stated in an interview that he had encouraged a group of elementary school children to masturbate because "the aspect of lust had to be developed"

"The FWOS seeks to understand, acquire and disseminate knowledge about children's sexual behaviour and sexual experience..."

FWOS is the legal successor of the work of Brongersma, who frequently abused Asian sex slaves, was imprisoned for molesting a young boy, owned a vast collection of child pornography, and published a magazine that vividly promoted child abuse.

FWOS is one of the financiers of Rutgers - the foundation appointed by the WHO and UN to create school material in 27 nations.

The news media have also joined in the worldwide operation to normalise paedophilia. Here is a small compilation of what is in reality a true avalanche of articles, all having one mission: to convince the world that paedophiles are good people, and those who defend the children are monsters.


Official of WHO and UN arrested for child molestation

The paedophile practices of high ranking officials from the World Health Organisation and the United Nations is usually carefully covered up.
