  - *Use of Metropolitan Police vehicles to transport or escort protest groups*
  - *Logs or authorisations for movement of individuals from Epping Railway Station to the protest site and back*
  - *Any coordination with Essex Police regarding transport or protection of counter-demonstrators*
3. *Risk Assessments and Intelligence Briefings*
  - *Documents assessing the risk of disorder, group affiliations, or anticipated protest behaviour*
  - *Any mention of groups such as Stand Up to Racism, Unite Against Fascism, or Antifa-aligned activists*
4. *Inter-Agency Correspondence*
  - *Communications between the Metropolitan Police and Essex Police or Epping Forest District Council regarding protest logistics, transport, or public*

*order strategy*

*5. Authorisation of Group Escort*

*- Name, rank, and department of officer(s) who authorised the escort or transport of activist groups*

Your request will now be considered in accordance with the Freedom of Information Act 2000 (the Act). You will receive a response within the statutory timescale of 20 working days as defined by the Act.

Due to an increase in the volume of work received by Data Rights we regret to inform you that we have fallen behind in our processing and are experiencing delays.

We can assure you we are working as fast as we can to process your request and we are looking into ways to increase our staffing to accommodate the increase of work received by the MPS.

## **COMPLAINT RIGHTS**

**Are you unhappy with how your request has been handled or do you think the decision is incorrect?**

You have the right to require the Metropolitan Police Service (MPS) to review their decision.

Prior to lodging a formal complaint you are welcome to discuss the response with the case officer who dealt with your request.

### **Complaint**

If you are dissatisfied with the handling procedures or the decision of the MPS made under the Freedom of Information Act 2000 (the Act) regarding access to information you can lodge a complaint with the MPS to have the decision reviewed.

Complaints should be made in writing, within forty (40) working days from the date of the refusal notice, and addressed to:

In all possible circumstances the MPS will aim to respond to your complaint within 20 working days.

### **The Information Commissioner**

After lodging a complaint with the MPS if you are still dissatisfied with the decision you may make application to the Information Commissioner for a decision on whether the request for information has been dealt with in accordance with the requirements of the Act.
